DIGEST OF SB 22 (Updated February 16, 2012 7:39 am - DI 118)

Citations Affected: IC 14-33.

Synopsis: Conservancy district director compensation. Provides compensation for directors of conservancy districts commensurate with their workload and responsibilities. Provides that compensation may not be based upon a tax assessment imposed by the district.

Effective: July 1, 2012.

ENGROSSED SENATE BILL No. 22

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 14-33-5-16, AS AMENDED BY P.L.78-2007,
2 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2012]: Sec. 16. **(a) As compensation Except as provided in**
4 **subsection (b), upon approval of the initial district plan,** the
5 directors are entitled to **compensation in** an amount that the court
6 orders, but not to exceed:
7 (1) one hundred dollars (\$100) for not more than two (2) regular
8 or specially called board meetings per month; and
9 (2) fifty dollars (\$50) for not more than five (5) days per month
10 devoted to the work of the district in addition to any day for which
11 payment is received under subdivision (1). In addition, the
12 directors shall be reimbursed for actual expenses, including
13 traveling expense at a rate equal to the rate paid to state officers
14 and employees. Claims for expense reimbursement must be
15 accompanied by an itemized written statement approved by a
16 recorded motion of the board.

COMMITTEE REPORT

Mr. Speaker: Your Committee on Natural Resources, to which was referred Senate Bill 22, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill be amended as follows:

Page 1, line 3, after "16." insert "(a)".

Page 1, line 4, delete "section 16.1 of this chapter," and insert "**subsection (b), upon approval of the initial district plan,**".

Page 1, delete lines 16 through 17, begin a new paragraph and insert:

"(b) At any time after all directors have been elected to the board, the directors may receive an increase in compensation up to a reasonable amount that is:

- (1) approved by a majority vote of the board of directors; and**
- (2) authorized by a court order.**

(c) An increase in compensation authorized under subsection (b) may not be based upon an increase of any tax, assessment, rates, or charges by the district.

(d) In addition to any compensation the directors may receive under subsection (b), the directors shall be reimbursed for actual expenses, including traveling expenses at a rate equal to the rate paid to state officers and employees. Claims for expense reimbursement must be accompanied by an itemized written statement approved by a recorded motion of the board of directors."
