A BILL FOR AN ACT to amend the Indiana Code concerning the general assembly.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 2-1-12.5 IS ADDED TO THE INDIANA CODE

5 **Sec. 1. (a) Notwithstanding the report of the 2010 decennial**  
6 **census for Indiana and the information contained in the GIS on**  
7 **June 30, 2011, the following census blocks located in Elkhart**  
8 **County are, from July 1, 2011, considered part of House District 49**  
9 **and not part of House District 48:**

13 **(b) The office shall make the appropriate changes to the GIS to**  
14 **implement this section.**
