MR. SPEAKER:

I move that Engrossed Senate Bill 142 be amended to read as follows:

- 1 Page 9, after line 17, begin a new paragraph and insert:
- 2 "SECTION 9. IC 36-7-14-13 IS AMENDED TO READ AS
- 3 FOLLOWS [EFFECTIVE JULY 1, 2012]: Sec. 13. (a) Within thirty
- 4 (30) days after the close of each calendar year, the redevelopment
- 5 commissioners shall file with the unit's executive a report setting out
- 6 their activities during the preceding calendar year.
- 7 (b) The report of the commissioners of a municipal redevelopment
- 8 commission must show the names of the then qualified and acting
- 9 commissioners, the names of the officers of that body, the number of
- 10 regular employees and their fixed salaries or compensation, the amount
- 11 of the expenditures made during the preceding year and their general
- 12 purpose, **an accounting of the tax increment revenues expended by**
- 13 **any entity receiving the tax increment revenues as a grant or loan**
- 14 **from the commission**, the amount of funds on hand at the close of the
- 15 calendar year, and other information necessary to disclose the activities
- 16 of the commissioners and the results obtained.
- 17 (c) The report of the commissioners of a county redevelopment
- 18 commission must show all the information required by subsection (b),
- 19 plus the names of any commissioners appointed to or removed from
- 20 office during the preceding calendar year.
- 21 (d) **A copy of each report filed under this section must be**
- 22 **submitted to the department of local government finance in an**
- 23 **electronic format under IC 5-14-6.**
- 24 SECTION 10. IC 36-7-15.1-36.3 IS ADDED TO THE INDIANA

1 CODE AS A NEW SECTION TO READ AS FOLLOWS
2 [EFFECTIVE JULY 1, 2012]: **Sec. 36.3. (a) Within thirty (30) days**
3 **after the close of each calendar year, the commission shall file with**
4 **the mayor a report setting out the commission's activities during**
5 **the preceding calendar year.**
6 (b) The report required by subsection (a) must show the names
7 of the then qualified and acting commissioners, the names of the
8 officers of that body, the number of regular employees and their
9 fixed salaries or compensation, the amount of the expenditures
10 made during the preceding year and their general purpose, an
11 accounting of the tax increment revenues expended by any entity
12 receiving the tax increment revenues as a grant or loan from the
13 commission, the amount of funds on hand at the close of the
14 calendar year, and other information necessary to disclose the
15 activities of the commission and the results obtained.
16 (c) A copy of each report filed under this section must be
17 submitted to the department of local government finance in an
18 electronic format under IC 5-14-6."
