MR. SPEAKER:

I move that Engrossed Senate Bill 286 be amended to read as follows:

- 1 Page 38, line 6, after "." insert "**The report required by this**
- 2 **subsection is due before the first day of the month following the**
- 3 **month in which the local child fatality review team makes its**
- 4 **findings.**".
- 5 Page 38, between lines 21 and 22, begin a new paragraph and insert:
- 6 "**(e) Not more than twenty-four (24) hours after receiving a**
- 7 **report under subsection (c) or IC 31-33-25-10(d), the department**
- 8 **shall:**
- 9 **(1) issue a public release detailing the nature and**
- 10 **circumstances of each fatality covered by the reports; and**
- 11 **(2) post the information described in subdivision (1) on the**
- 12 **Indiana transparency Internet web site.**".
- 13 Page 39, between lines 29 and 30, begin a new paragraph and insert:
- 14 "SECTION 48. IC 31-33-25-10, AS ADDED BY P.L.145-2006,
- 15 SECTION 288, IS AMENDED TO READ AS FOLLOWS
- 16 [EFFECTIVE JULY 1, 2012]: Sec. 10. (a) Except as provided in
- 17 subsection (b), meetings of the statewide child fatality review
- 18 committee are open to the public.
- 19 (b) ~~Except as provided in subsection (d)~~; A meeting of the statewide
- 20 child fatality review committee that involves:
- 21 (1) confidential records; or
- 22 (2) identifying information regarding the death of a child that is
- 23 confidential under state or federal law;
- 24 shall be held as an executive session.

1 (c) If a meeting is held as an executive session under subsection (b),
2 each individual who:
3 (1) attends the meeting; and
4 (2) is not a member of the statewide child fatality review
5 committee;
6 shall sign a confidentiality statement prepared by the department. The
7 statewide child fatality review committee shall keep all confidentiality
8 statements signed under this subsection.
9 (d) A majority of the members of the statewide child fatality review
10 committee may vote to disclose any report or part of a report regarding
11 a fatality review to the public if the information is in the general public
12 interest as determined by the statewide child fatality review committee.
13 **(d) The statewide child fatality review committee shall report to**
14 **the department its findings for each child fatality that the statewide**
15 **child fatality review committee reviews. The report required by**
16 **this subsection is due before the first day of the month following**
17 **the month in which the statewide child fatality review committee**
18 **makes its findings."**
19 Renumber all SECTIONS consecutively.
