I move that Engrossed Senate Bill 287 be amended to read as follows:

- 1 Page 4, between lines 40 and 41, begin a new paragraph and insert:
- 2 "SECTION 4. IC 10-11-2-33 IS ADDED TO THE INDIANA CODE
- 3 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 4 1, 2012]: **Sec. 33. (a) The superintendent is the director of the**
- 5 **department of child services under IC 31-25-1-1.**
- 6 **(b) Employees of the department of child services (established**
- 7 **as a division of the state police department on July 1, 2012) are**
- 8 **civilian employees and eligible for pensions and benefits that were**
- 9 **available to department of child services employees on June 30,**
- 10 **2012."**
- 11 Page 54, between lines 8 and 9, begin a new paragraph and insert:
- 12 "SECTION 87. IC 31-25-1-1, AS ADDED BY P.L.145-2006,
- 13 SECTION 271, IS AMENDED TO READ AS FOLLOWS
- 14 [EFFECTIVE JULY 1, 2012]: Sec. 1. (a) The department of child
- 15 services is established as a **division of the state police department**
- 16 **established under IC 10-11-2-4.**
- 17 (b) ~~The governor shall appoint a superintendent of the state police~~
- 18 **department appointed under IC 10-11-2-6 is the** director who is
- 19 responsible for administering the department of child services. ~~The~~
- 20 ~~director:~~
- 21 (1) ~~serves at the governor's pleasure; and~~
- 22 (2) ~~is entitled to compensation set by the budget agency."~~
- 23 Page 143, after line 20, begin a new paragraph and insert:
- 24 "SECTION 186. [EFFECTIVE JULY 1, 2012] **(a) On July 1, 2012,**

1       **the state police department becomes the owner of all the personal**  
2       **property of the department of child services due to the department**  
3       **of child services becoming a division within the state police**  
4       **department as required by this act.**  
5       **(b) This SECTION expires December 31, 2012.**  
6       SECTION 187. [EFFECTIVE JULY 1, 2012] **(a) The funds that**  
7       **remain in any fund controlled by the department of child services**  
8       **on June 30, 2012, shall be transferred to the state police**  
9       **department on July 1, 2012.**  
10       **(b) This SECTION expires December 31, 2012.**  
11       SECTION 188. [EFFECTIVE JULY 1, 2012] **The rules adopted by**  
12       **the department of child services before July 1, 2012, are**  
13       **considered, after June 30, 2012, rules of the state department of**  
14       **police."**  
15       Renumber all SECTIONS consecutively.
