13 **approval of the general assembly.**

22 SECTION 163. IC 31-37-5-10 IS ADDED TO THE INDIANA
23 CODE AS A **NEW** SECTION TO READ AS FOLLOWS

1 not decrease rates paid to a home or facility under this chapter
 2 without approval of the general assembly.

 5 Page 143, after line 20, begin a new paragraph and insert:
 6 "SECTION 188. [EFFECTIVE UPON PASSAGE] (a) The
 7 department of child services shall prepare a report concerning the
 8 following:
 9 (1) A listing by category, the number of placements for
 10 children, including:
 11 (A) foster family homes;
 12 (B) group homes; and
 13 (C) other homes or facilities in which the department
 14 places children;
 15 in each county for the calendar years 2007, 2008, 2009, 2010,
 16 and 2011.
 17 (2) A listing by category, the amount of money that the
 18 department of child services has spent on:
 19 (A) foster family homes;
 20 (B) group homes; and
 21 (C) other homes or facilities in which the department
 22 places children;
 23 in each county for the calendar years 2007, 2008, 2009, 2010,
 24 and 2011.
 25 SECTION 189. An emergency is declared for this act."
 26 Renumber all SECTIONS consecutively.
