I move that Engrossed Senate Bill 327 be amended to read as follows:

- 1 Page 2, between lines 15 and 16, begin a new paragraph and insert:
2 "SECTION 4. IC 9-13-2-196.5, AS ADDED BY P.L.58-2006,
3 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
4 JULY 1, 2012]: Sec. 196.5. (a) "Veteran", for purposes of IC 9-18-50,
5 has the meaning set forth in IC 9-18-50-1.
6 (b) "Veteran", for purposes of IC 9-18-55, has the meaning set
7 forth in IC 9-18-55-1."
8 Page 14, line 11, strike "or".
9 Page 14, line 13, after "plates);" insert "**or**
10 (AA) IC 9-18-55 (Vietnam veterans trust license plates);".
11 Page 19, between lines 24 and 25, begin a new paragraph and insert:
12 "SECTION 50. IC 9-18-25-1, AS AMENDED BY P.L.87-2010,
13 SECTION 18, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
14 JULY 1, 2012]: Sec. 1. This chapter does not apply to the following:
15 (1) Antique motor vehicle license plates (IC 9-18-12).
16 (2) Recovery vehicle license plates (IC 9-18-13).
17 (3) Personalized license plates (IC 9-18-15).
18 (4) Prisoner of war license plates (IC 9-18-17).
19 (5) Disabled Hoosier veteran license plates (IC 9-18-18).
20 (6) Purple Heart license plates (IC 9-18-19).
21 (7) Indiana National Guard license plates (IC 9-18-20).
22 (8) Person with a disability license plates (IC 9-18-22).
23 (9) Amateur radio operator license plates (IC 9-18-23).
24 (10) In God We Trust license plates (IC 9-18-24.5).

- 1 (11) Pearl Harbor survivor license plates (IC 9-18-45.8).
- 2 (12) Hoosier veteran license plates (IC 9-18-50).
- 3 (13) Support our troops license plates (IC 9-18-51).
- 4 (14) Abraham Lincoln bicentennial license plates (IC 9-18-52).
- 5 (15) Indiana Gold Star family member license plates (IC 9-18-54).
- 6 **(16) Vietnam veterans trust license plates (IC 9-18-55)."**

7 Page 26, line 10, delete "(b)" and insert "(d)".

8 Page 34, between lines 36 and 37, begin a new paragraph and insert:
 9 "SECTION 96. IC 9-18-55 IS ADDED TO THE INDIANA CODE
 10 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
 11 JULY 1, 2012]:

12 **Chapter 55. Vietnam Veterans Trust License Plates**

13 **Sec. 1. As used in this chapter, "veteran" refers to an individual**
 14 **who served as a member of the armed forces of the United States**
 15 **at any time from August 5, 1964, through May 7, 1975 (Vietnam**
 16 **Conflict).**

17 **Sec. 2. The bureau shall design a Vietnam veterans trust license**
 18 **plate to be issued beginning January 1, 2013.**

19 **Sec. 3. A Vietnam veterans trust license plate must include the**
 20 **following:**

- 21 (1) A basic design for the plate with consecutive numbers or
- 22 letters, or both, to properly identify the vehicle.
- 23 (2) A background design or colors that designate the license
- 24 plate as a Vietnam veterans trust license plate.
- 25 (3) Any other information the bureau considers necessary.

26 **Sec. 4. The bureau shall confer with members of armed forces**
 27 **retiree organizations concerning the design of the Vietnam**
 28 **veterans trust license plate and the emblems denoting the branch**
 29 **of service or conflict in which a particular veteran served.**

30 **Sec. 5. A Vietnam veterans trust license plate issued under this**
 31 **chapter may be displayed on the following:**

- 32 (1) A passenger motor vehicle.
- 33 (2) A truck registered as a truck with a declared gross weight
- 34 of not more than eleven thousand (11,000) pounds.
- 35 (3) A recreational vehicle.
- 36 (4) A motorcycle.

37 **Sec. 6. A veteran who is a resident of Indiana and eligible to**
 38 **register a vehicle listed in section 5 of this chapter may apply for**
 39 **and receive a Vietnam veterans trust license plate for one (1) or**
 40 **more vehicles upon doing the following:**

- 41 (1) Completing an application for a Vietnam veterans trust
- 42 license plate.
- 43 (2) Presenting:
 - 44 (A) a United States Uniformed Services Retiree
 - 45 Identification Card;
 - 46 (B) a DD 214 record;
 - 47 (C) United States military discharge papers; or

- 1 **(D) a current armed forces identification card;**
- 2 **to the bureau.**
- 3 **(3) Paying the fees under section 7 of this chapter.**
- 4 **Sec. 7. (a) The fees for a Vietnam veterans trust license plate are**
- 5 **set forth in IC 9-29-5-38.7.**
- 6 **(b) The annual supplemental fee described in**
- 7 **IC 9-29-5-38.7(a)(2) shall be:**
- 8 **(1) collected by the bureau; and**
- 9 **(2) deposited in the operation homefront trust fund**
- 10 **established by section 8 of this chapter.**
- 11 **Sec. 8. (a) The operation homefront trust fund is established.**
- 12 **(b) The treasurer of state shall invest the money in the fund not**
- 13 **currently needed to meet the obligations of the fund in the same**
- 14 **manner as other public funds are invested. Interest that accrues**
- 15 **from these investments shall be deposited in the fund. Money in the**
- 16 **fund is continuously appropriated for the purposes of this section.**
- 17 **(c) The commissioner shall administer the fund. Expenses of**
- 18 **administering the fund shall be paid from money in the fund.**
- 19 **(d) On June 30 of each year, the commissioner shall distribute**
- 20 **the money from the fund to the Indiana chapter of Operation**
- 21 **Homefront.**
- 22 **(e) Money in the fund at the end of a state fiscal year does not**
- 23 **revert to the state general fund."**
- 24 Page 39, between lines 38 and 39, begin a new paragraph and insert:
- 25 "SECTION 106. IC 9-29-5-38.7 IS ADDED TO THE INDIANA
- 26 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 27 [EFFECTIVE JULY 1, 2012]: **Sec. 38.7. (a) A vehicle registered**
- 28 **under IC 9-18-55 is subject to:**
- 29 **(1) an annual registration fee;**
- 30 **(2) an annual supplemental fee of twenty-five dollars (\$25);**
- 31 **and**
- 32 **(3) any other fee or tax required of a person registering a**
- 33 **vehicle under this title.**
- 34 **(b) The bureau shall collect from each registration the annual**
- 35 **supplemental fee described in subsection (a)(2).**

- 1 **(c) The bureau shall deposit the annual supplemental fee**
- 2 **described in subsection (a)(2) in the operation homefront trust**
- 3 **fund established under IC 9-18-55-8(a).".**
- 4 Renumber all SECTIONS consecutively.
