MR. SPEAKER:

I move that Engrossed Senate Bill 327 be amended to read as follows:

- 1 Page 24, between lines 7 and 8, begin a new paragraph and insert:
2 "SECTION 56. IC 9-18-25-3.5 IS ADDED TO THE INDIANA
3 CODE AS A NEW SECTION TO READ AS FOLLOWS
4 [EFFECTIVE JANUARY 1, 2012 (RETROACTIVE)]: **Sec. 3.5. (a)**
5 **Notwithstanding any other section of this chapter to the contrary,**
6 **beginning January 1, 2012, the bureau may not approve, issue, or**
7 **renew a special group recognition license plate issued under this**
8 **chapter for a special group that encourages, supports, or promotes**
9 **any of the following:**
10 (1) Use of illegal drugs.
11 (2) Use of tobacco or tobacco products.
12 (3) Sexual activity involving a minor.
13 (4) Sexual activity outside of marriage not in accordance with
14 IC 20-30-5-13.
15 (5) Use of pornography.
16 (6) A lifestyle that is contrary to:
17 (A) IC 20-30-5-13; or
18 (B) marriage (as described in IC 31-11-1).
19 (7) The use of alcoholic beverages by an individual less than
20 twenty-one (21) years of age.
21 (8) Unlawful discrimination.
22 (b) The bureau shall identify each special group that
23 encourages, supports, or promotes any of the subjects set forth in
24 subsection (a) and upon identification shall terminate the special

1 **group's eligibility within the special group recognition license plate**
 2 **program. Upon termination of the eligibility, the bureau shall:**
 3 **(1) inform a holder of the special group recognition license**
 4 **plate that the license plate expires thirty (30) days after the**
 5 **date of the notice from the bureau to the holder;**
 6 **(2) refund any:**
 7 **(A) annual supplemental fee collected under**
 8 **IC 9-29-5-38(a)(2) or IC 9-29-5-38(d)(2); and**
 9 **(B) annual fee collected by the bureau under section 17.7**
 10 **of this chapter and IC 9-29-5, whether or not the annual**
 11 **fee has been distributed to any trust fund established**
 12 **under section 17.7 of this chapter;**
 13 **to the holder of the special group recognition license plate;**
 14 **and**
 15 **(3) issue a standard license plate in accordance with**
 16 **IC 9-18-2-30."**
 17 Page 26, line 10, delete "(b)" and insert "(d)".
 18 Page 47, line 8, delete "IC 9-30-13-0.5" and insert "IC 9-30-13-0.8".
 19 Page 47, line 10, delete "0.5." and insert "0.8".
 20 Renumber all SECTIONS consecutively.
