MR. SPEAKER:

I move that House Bill 1001 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 5-28-29-36 IS ADDED TO THE INDIANA CODE
- 4 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE
- 5 UPON PASSAGE]: **Sec. 36. (a) The definitions in P.L.229-2011,**
- 6 **SECTION 1 apply throughout this section.**
- 7 **(b) In addition to the appropriations made to the Indiana**
- 8 **economic development corporation by P.L.229-2011, the budget**
- 9 **agency shall transfer twenty million dollars (\$20,000,000) from**
- 10 **amounts that would otherwise be reverted from other funds to the**
- 11 **Indiana economic development corporation for the total operating**
- 12 **expenses of the capital access program established under this**
- 13 **chapter. The budget agency shall exercise the agency's authority**
- 14 **under IC 4-12-1-12 to reassign appropriations made from other**
- 15 **funds to carry out the transfer required by this section before July**
- 16 **1, 2012.**
- 17 **(c) The amount transferred under subsection (b) may not be**
- 18 **used for administrative expenses. The amount transferred shall be**
- 19 **deposited in the reserve fund and used to provide capital to**
- 20 **businesses, particularly small and medium sized businesses, to**
- 21 **foster economic development in Indiana.**
- 22 **(d) Notwithstanding any other law or the expiration of this**
- 23 **section, the amount transferred under subsection (b):**
- 24 **(1) may not be transferred or reassigned to another purpose**

1 **or fund;**
2 **(2) does not revert to the state general fund or any other fund**
3 **at the end of a state fiscal year and remains available in**
4 **subsequent state fiscal years for the purposes of the capital**
5 **access program established under this chapter; and**
6 **(3) may be allotted and expended only for the purposes of the**
7 **capital access program established under this chapter.**
8 **IC 4-13-2-18(f) does not apply to an amount reassigned under this**
9 **section or any other amount transferred or allotted to the purposes**
10 **of the capital access program established under this chapter.**
11 **(e) This section expires July 1, 2019."**
12 Page 1, line 4, delete "Right to Work" and insert "**Labor**
13 **Organization Membership**".
14 Page 2, delete lines 41 through 42, begin a new paragraph and
15 insert:
16 **"Sec. 7. A person may not require an individual to become or**
17 **remain a member of a labor organization.**
18 **Sec. 8. Nothing in this chapter shall be construed to prohibit**
19 **collective bargaining agreements that require the payment of**
20 **representation fees."**
21 Delete page 3.
22 Page 4, delete lines 1 through 4.
23 Renumber all SECTIONS consecutively.
