MR. SPEAKER:

I move that House Bill 1001 be amended to read as follows:

- 1 Replace the effective date in SECTION 1 with "[EFFECTIVE
- 2 NOVEMBER 5, 2012]".
- 3 Page 4, line 1, delete "March 14," and insert "**November 5,**".
- 4 Page 4, line 4, delete "March 14," and insert "**November 5,**".
- 5 Page 4, delete line 5, begin a new paragraph and insert:
- 6 "**Sec. 13. (a) This section does not apply if the following public**
- 7 **question is approved by the voters of Indiana at the November 6,**
- 8 **2012 general election:**
- 9 "**Should it be unlawful for an employer to require an**
- 10 **individual to become or remain a member of a labor**
- 11 **organization or pay dues, fees, assessments, or other charges**
- 12 **of any kind or amount to a labor organization as a condition**
- 13 **of employment or continuation of employment (a "right to**
- 14 **work" law)?".**
- 15 **(b) Except as provided in subsection (a), this chapter expires**
- 16 **November 7, 2012.**
- 17 **Sec. 14. IC 1-1-1-8 does not apply to this chapter.**
- 18 SECTION 2. [EFFECTIVE JULY 1, 2012] **(a) The county election**
- 19 **board of each county shall place the following public question on**
- 20 **the ballot at the November 2012 general election:**
- 21 "**Should it be unlawful for an employer to require an**
- 22 **individual to become or remain a member of a labor**
- 23 **organization or pay dues, fees, assessments, or other charges**
- 24 **of any kind or amount to a labor organization as a condition**

- 1 of employment or continuation of employment (a "right to
- 2 work" law)?".
- 3 **(b) Each county election board shall:**
- 4 **(1) tabulate the votes cast on the public question stated in**
- 5 **subsection (a); and**
- 6 **(2) certify the results under IC 3-12-4-9.**
- 7 **(c) IC 3 applies to the public question required by this**
- 8 **SECTION except where IC 3 conflicts with this SECTION.**
- 9 **(d) The secretary of state shall certify the results of the vote in**
- 10 **each county on the public question required by this SECTION to**
- 11 **each of the following:**
- 12 **(1) The speaker of the house of representatives.**
- 13 **(2) The minority leader of the house of representatives.**
- 14 **(3) The president pro tempore of the senate.**
- 15 **(4) The minority leader of the senate.**
- 16 **(5) The governor.**
- 17 **(e) This SECTION expires July 1, 2013."**
