MR. SPEAKER:

I move that House Bill 1002 be amended to read as follows:

- 1 Page 36, delete lines 23 through 36, begin a new paragraph and
2 insert:
3 "SECTION 47. IC 5-28-28-10 IS ADDED TO THE INDIANA
4 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
5 [EFFECTIVE JULY 1, 2012]: **Sec. 10. In addition to the other**
6 **requirements of this chapter, the economic incentives and**
7 **compliance report must also include detailed information on the**
8 **financial status of the following programs, resources, or activities**
9 **for which the corporation is responsible:**
10 **(1) Small business development under IC 5-28-17, including:**
11 **(A) detailed information on the corporation's efforts to**
12 **support the development of small businesses under**
13 **IC 5-28-17; and**
14 **(B) an evaluation of the results of the corporation's efforts**
15 **to encourage the development of small businesses under**
16 **IC 5-28-17.**
17 **(2) The small business development fund established under**
18 **IC 5-28-18-7.**
19 **(3) The small business incubator program under IC 5-28-21,**
20 **including:**
21 **(A) the number of applications for incubators received by**
22 **the corporation;**
23 **(B) the number of applications for incubators approved by**
24 **the corporation;**

- 1 (C) the number of incubators created under this chapter;
- 2 (D) the number of tenants occupying each incubator;
- 3 (E) the occupancy rate of each incubator;
- 4 (F) the number of jobs provided by each incubator and the
- 5 tenants of each incubator;
- 6 (G) the number of firms still operating in Indiana after
- 7 leaving incubators and the number of jobs provided by
- 8 those firms; and
- 9 (H) the reasons firms that were established in an incubator
- 10 have moved to another state.
- 11 **(4) Efforts to promote business modernization of and the**
- 12 **adoption of technology by Indiana businesses under**
- 13 **IC 5-28-23.**

14 SECTION 48. IC 5-28-28-11 IS ADDED TO THE INDIANA
 15 CODE AS A NEW SECTION TO READ AS FOLLOWS
 16 [EFFECTIVE JULY 1, 2012]: **Sec. 11. The corporation shall conduct**
 17 **an annual public hearing to receive comments from interested**
 18 **parties regarding the annual report required by this chapter, and**
 19 **notice of the hearing shall be given at least fourteen (14) days**
 20 **before the hearing in accordance with IC 5-14-1.5-5(b)."**
