HOUSE MOTION _____

MR. SPEAKER:

I move that House Bill 1002 be amended to read as follows:

- 1 Page 28, between lines 3 and 4, begin a new paragraph and insert:
- 2 "SECTION 30. IC 5-2-6-16, AS AMENDED BY P.L.44-2006,
- 3 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 4 JULY 1, 2012]: Sec. 16. (a) As used in this chapter, "local coordinating
- 5 council" means a countywide citizen body approved and appointed by
- 6 the commission for a drug free Indiana to plan, monitor, and evaluate
- 7 comprehensive local alcohol and drug abuse plans.
- 8 (b) The commission for a drug free Indiana is established (referred
- 9 to in this section as "commission"). The criminal justice institute may
- 10 adopt rules under IC 4-22-2 to administer the commission. The
- 11 commission must consist of twenty (20) members described under
- 12 ~~subsections~~ **subsection (d) and (e)** who have distinguished themselves
- 13 in their respective fields and who have experience or an interest in
- 14 attempting to eliminate alcohol and other drug abuse in Indiana.
- 15 (c) The commission's purpose is to improve the coordination of
- 16 alcohol and other drug abuse efforts at both the state and local levels
- 17 in an effort to eliminate duplication of efforts while ensuring that
- 18 comprehensive alcohol and other drug programs are available
- 19 throughout Indiana. The commission's responsibilities include the
- 20 following:
- 21 (1) Establishing an interagency council on drugs to coordinate the
- 22 alcohol and other drug education, prevention, treatment, and
- 23 justice programming and funding responsibilities of state
- 24 agencies, commissions, and boards including the approval of

- 1 alcohol and other drug plans and funding applications by state
 2 agencies, commissions, and boards.
- 3 (2) Coordinating the collection of data concerning alcohol and
 4 other drug abuse and the needs, programming, and effectiveness
 5 of state supported programs and services.
- 6 (3) Maintaining a system of support to assist local coordinating
 7 councils with technical assistance, guidance, or direct funding
 8 resources.
- 9 (4) Continuing to assist the development of local coordinating
 10 councils to identify community drug programs, coordinate
 11 community initiatives, design comprehensive, collaborative
 12 community strategies, and monitor anti-drug activities at the local
 13 level.
- 14 (5) Establishing roles, responsibilities, and performance standards
 15 for the local coordinating councils.
- 16 (6) Recommending to the governor and general assembly long
 17 and short range goals, objectives, and strategies, including
 18 legislative proposals to be implemented on the state and local
 19 level to reduce drug abuse.
- 20 (7) Assisting local communities in the development of citizen
 21 based drug related crime control efforts.
- 22 (d) The commission must be comprised of the following voting
 23 members:
- 24 (1) The governor or the governor's designee.
- 25 (2) Fifteen (15) members appointed by the governor for a two (2)
 26 year term, who have experience or expertise in at least one (1) of
 27 the following areas:
- 28 (A) Family relations.
- 29 (B) Religion.
- 30 (C) Education.
- 31 (D) Civic or private organizations.
- 32 (E) Business.
- 33 (F) Media.
- 34 (G) Drug treatment.
- 35 (H) Medicine.
- 36 (I) Local government.
- 37 (J) Judiciary.
- 38 (K) Law enforcement.
- 39 (L) Self-help organizations.
- 40 (M) Youth.
- 41 (N) A representative of the interagency council against drugs
 42 established under subsection (c)(1).
- 43 (O) Labor.
- 44 **(3) Four (4) members of the general assembly. The president**
 45 **pro tempore of the senate shall appoint two (2) senators, both**
 46 **of whom may not be members of the same political party. The**

- 1 **speaker of the house of representatives shall appoint two (2)**
 2 **representatives, both of whom may not be members of the**
 3 **same political party.**
- 4 ~~(e)~~ **(f)** Four ~~(4)~~ members of the general assembly shall serve as
 5 nonvoting members of the commission. The president pro tempore of
 6 the senate shall appoint two ~~(2)~~ senators; both of whom may not be
 7 members of the same political party. The speaker of the house of
 8 representatives shall appoint two ~~(2)~~ representatives; both of whom
 9 may not be members of the same political party.
- 10 ~~(f)~~ **(e)** The governor or the governor's designee shall serve as the
 11 chairman of the commission.
- 12 ~~(g)~~ **(f)** The commission shall meet one (1) time per month at the call
 13 of the chairman.
- 14 ~~(h)~~ **(g)** ~~Eight (8)~~ **Eleven (11)** voting members of the commission
 15 constitute a quorum. The commission is not prohibited from
 16 conducting business as a result of a vacancy in the commission. In the
 17 case of a vacancy, a new appointee shall serve for the remainder of the
 18 unexpired term. A vacancy shall be filled from the same group that was
 19 represented by the outgoing member.
- 20 ~~(i)~~ **(h)** All appointments of the commission's members are
 21 renewable.
- 22 ~~(j)~~ **(i)** A member of the commission who is not a state employee is
 23 not entitled to a minimum salary per diem provided by
 24 IC 4-10-11-2.1(b). The member is, however, entitled to reimbursement
 25 for traveling expenses and other expenses actually incurred in
 26 connection with the member's duties, as provided in the state travel
 27 policies and procedures established by the Indiana department of
 28 administration and approved by the budget agency.
- 29 ~~(k)~~ **(j)** A member of the commission who is a state employee is
 30 entitled to reimbursement for traveling expenses and other expenses
 31 actually incurred in connection with the member's duties, as provided
 32 in the state travel policies and procedures established by the Indiana
 33 department of administration and approved by the budget agency."
 34 Renumber all SECTIONS consecutively.
