MR. SPEAKER:

I move that House Bill 1005 be amended to read as follows:

- 1 Page 1, delete line 15, begin a new paragraph and insert:
- 2 "Sec. 4. Except as provided in section 5 of this chapter, an
- 3 individual:
- 4 (1) serving as a volunteer firefighter for a volunteer fire
- 5 department or a fire department that provides fire protection
- 6 services to a unit:
- 7 (A) under a contract with the unit, excluding a mutual aid
- 8 agreement; or
- 9 (B) as the unit's fire department; or
- 10 (2) serving as a police reserve officer (as defined in
- 11 IC 36-8-3-20);
- 12 may not assume or hold an elected office of a unit that receives
- 13 services from the department in which the volunteer firefighter or
- 14 police reserve officer serves.
- 15 Sec. 5. (a) As used in this section "department" refers to:
- 16 (1) a volunteer fire department or the fire department of a
- 17 unit; or
- 18 (2) a police department of a unit.
- 19 (b) Section 4 of this chapter does not apply to an individual who
- 20 receives for services provided to a department not more than two
- 21 hundred dollars (\$200) per month each taxable year, in addition to
- 22 the sum of any allowances received by the individual during the
- 23 taxable year for services provided to the department, including
- 24 allowances for any of the following:

- 1 **(1) Clothing.**
 - 2 **(2) Fuel.**
 - 3 **(3) Vehicle mileage.**
 - 4 **(4) Equipment.**
 - 5 **(c) This subsection applies to an individual who serves as a**
 - 6 **volunteer firefighter or police reserve officer in more than one (1)**
 - 7 **department. The requirements for an exemption under subsection**
 - 8 **(b) apply separately to each department in which the individual**
 - 9 **serves.**
 - 10 **(d) This subsection applies to an individual who serves as a**
 - 11 **volunteer firefighter in a department that contracts with more**
 - 12 **than one (1) unit for fire service. If the individual meets the**
 - 13 **requirements under subsection (b) with regard to the individual's**
 - 14 **service in the department, the individual is exempt from this**
 - 15 **chapter as to all units that contract with the department."**
 - 16 Page 2, delete lines 1 through 3.
 - 17 Page 2, line 4, delete "5." and insert "6."
 - 18 Page 2, line 4, delete "7" and insert "8".
 - 19 Page 2, line 8, delete "6." and insert "7."
 - 20 Page 2, delete lines 12 through 15, begin a new line block indented
 - 21 and insert:
 - 22 **"(2) a volunteer firefighter or police reserve officer from**
 - 23 **assuming an elected office of a unit other than the unit**
 - 24 **receiving services from the department in which the volunteer**
 - 25 **firefighter or police reserve officer serves; or"**
 - 26 Page 2, line 19, delete "7." and insert "8."
 - 27 Page 2, line 19, delete "5" and insert "6".
 - 28 Page 2, line 27, delete "5" and insert "6".
