MR. SPEAKER:

I move that House Bill 1205 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 20-24-9-6, AS ADDED BY P.L.1-2005, SECTION
- 4 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,
- 5 2012]: Sec. 6. **(a)** The organizer of a charter school shall publish an
- 6 annual performance report that provides the information required under
- 7 IC 20-20-8-8 in the same manner that a school corporation publishes
- 8 an annual report under IC 20-20-8.
- 9 **(b) In addition to the information required under IC 20-20-8-8,**
- 10 **the organizer shall publish the salary and benefits of each:**
- 11 **(1) superintendent, principal, or equivalent authority**
- 12 **employed by the organizer for a charter school;**
- 13 **(2) board member of a charter school; and**
- 14 **(3) board member or chief executive of a sponsor of a charter**
- 15 **school;**
- 16 **in the charter school's annual performance report required under**
- 17 **subsection (a). The information shall be published on the**
- 18 **department's Internet web site as described in IC 20-20-8-3.**
- 19 SECTION 2. IC 20-24-9-7 IS ADDED TO THE INDIANA CODE
- 20 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 21 1, 2012]: Sec. 7. **Before January 1 of each year, each board member**
- 22 **of a charter school and each board member or chief executive of a**
- 23 **sponsor of a charter school shall file with the department a**
- 24 **statement of economic interest for the preceding calendar year.**

- 1 **The statement of economic interest must include the following:**
2 **(1) The name of the board member's or chief executive's**
3 **employer and the employer of the board member's or chief**
4 **executive's spouse and the nature of the employer's business.**
5 **(2) The name of any sole proprietorship owned or professional**
6 **practice operated by the board member or chief executive or**
7 **the board member's or chief executive's spouse and the nature**
8 **of the business.**
9 **(3) The name of any partnership of which the board member**
10 **or chief executive or the board member's or chief executive's**
11 **spouse is a member and the nature of the partnership's**
12 **business.**
13 **(4) The name of any corporation of which the board member**
14 **or candidate or the board member's or chief executive's**
15 **spouse is an officer or director and the nature of the**
16 **corporation's business. Churches need not be listed.**
17 **(5) The name of any corporation in which the board member**
18 **or chief executive or the board member's or chief executive's**
19 **spouse or unemancipated children own stock or stock options**
20 **having a fair market value in excess of ten thousand dollars**
21 **(\$10,000). No time or demand deposit in a financial institution**
22 **or insurance policy need be listed.**
23 **(6) The name of any state agency or the supreme court of**
24 **Indiana that licenses or regulates the following:**
25 **(A) The board member's or chief executive's or the board**
26 **member's or chief executive's spouse's profession or**
27 **occupation.**
28 **(B) Any proprietorship, partnership, corporation, or**
29 **limited liability company listed under subdivision (2), (3),**
30 **or (4) and the nature of the licensure or regulation.**
31 **The requirement to file certain reports with the secretary of**
32 **state or to register with the department of state revenue as a**
33 **retail merchant, manufacturer, or wholesaler is not**
34 **considered as licensure or regulation.**
35 **(7) The name of any person or entity on whose behalf the**
36 **board member or chief executive has appeared before,**
37 **contacted, or transacted business with any state agency or**
38 **state agency official, the name of the state agency, the nature**
39 **of the appearance, contact, or transaction, and the cause**
40 **number, if any. This requirement does not apply when the**
41 **services are rendered without compensation.**
42 **(8) The name of any limited liability company of which the**
43 **board member or chief executive, or the board member or**
44 **chief executive's individual spouse has an interest.**
45 **(b) The statements of economic interest required under**
46 **subsection (a) shall be filed on forms provided by the department.**
47 **The statements shall be kept by the department for one (1) year**

1 **after the expiration of the term during which they were filed. Any**
2 **statement filed must be open to public inspection and copies must**
3 **be made available to any person for a reasonable fee, as established**
4 **by the department."**

5 Renumber all SECTIONS consecutively.
