 3 "SECTION 37. [EFFECTIVE UPON PASSAGE] (a) As used in
 4 this SECTION, "task force" refers to the school accountability task
 5 force established by subsection (b).
 6 (b) The school accountability task force is established.
 7 (c) The legislative council shall appoint the members of the task
 8 force. Members appointed must include legislators, school
 9 corporation governing body members, teachers, school
 10 administrators, parents of students, and taxpayers. The legislative
 11 council shall appoint the chairperson of the task force, who must
 12 be a legislator.
 13 (d) The task force shall study and make recommendations to the
 14 general assembly concerning the following topics:
 15 (1) Providing interventions by the state to a school or school
 16 corporation in addition to those set forth in statute before the
 17 school or school corporation is considered for operation by a
 18 special management team. Interventions may include the
 19 following:
 20 (A) Additional and targeted state resources to address
 21 identified student deficiencies, including reading and math
 22 remediation programs, special education issues, and
 23 English language learner programs.
 24 (B) Instructional time flexibility, if the school or school
 25 corporation conducts the equivalent of at least one
 26 hundred eighty-five (185) student instructional days.
 27 (C) Imposing and funding class size restrictions.
 28 (D) Targeted professional development opportunities.
 29 (E) Fully funding full day kindergarten for the school or
 30 school corporation.
 31 (2) Selection criteria for special management teams, including
 32 the consideration of the following:
 33 (A) Comparing existing special management teams,
 34 considering offerings and service delivery models.
 35 (B) Understanding funding and internal operations.
 36 (C) Public transparency issues.
 37 (3) The impact of Indiana collective bargaining laws as
 38 related to the state takeover of a school or school corporation.
 39 (4) The appropriate scope of the state board of education's
 40 authority as opposed to legislative authority and direction.
 41 (5) Taxpayer issues and concerns with regard to takeover of
 42 public schools by private management teams.
 43 (6) Any other relevant matter.
 (e) The legislative services agency shall provide staff support to
 the task force.
 (f) The task force shall deliver its report and any
 recommendations to the legislative council before November 1,

2012. The report must be delivered in an electronic format under IC 5-14-6.

(g) This SECTION expires November 1, 2012.

SECTION 38. [EFFECTIVE UPON PASSAGE] (a) Notwithstanding any other law, the state board of education established by IC 20-19-2-2 may not adopt rules to carry out IC 20-31-8, IC 20-31-9, or IC 20-31-9.5, all as amended by this act, until after June 30, 2013.

(b) This SECTION expires July 1, 2013.

SECTION 39. An emergency is declared for this act."
