MR. SPEAKER:

*Your Committee on Roads and Transportation, to which was referred House Bill 1247, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 1, delete lines 1 through 17.
- 2 Page 2, delete lines 1 through 32, begin a new paragraph and insert
- 3 the following:
- 4 "SECTION 1. IC 9-24-12-1, AS AMENDED BY P.L.87-2010,
- 5 SECTION 30, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 6 UPON PASSAGE]: Sec. 1. (a) **Notwithstanding subsection (c) and**
- 7 **except as provided in subsections subsection (b) and (d) and section**
- 8 **sections 10, 11, and 12** of this chapter, **the expiration date for an**
- 9 **operator's license issued under this article before January 1, 2006;**
- 10 **expires at midnight of the birthday of the holder that occurs four (4)**
- 11 **years following the date of issuance: that contains a 2012 expiration**
- 12 **date is as follows:**
- 13 (1) **If the license was previously issued or renewed after May**
- 14 **14, 2007, and before January 1, 2008, the license expires at**

- 1 **midnight on the birthday of the holder that occurs five (5)**
 2 **years following the date of issuance.**
 3 **(2) If the license was previously issued or renewed after**
 4 **December 31, 2007, and before January 1, 2009, the license**
 5 **expires at midnight on the birthday of the holder that occurs**
 6 **six (6) years following the date of issuance.**
 7 **(3) If the license was previously issued or renewed after**
 8 **December 31, 2005, and before January 1, 2007, the license**
 9 **expires at midnight on the birthday of the holder that occurs**
 10 **four (4) years following the date of issuance.**

11 **This subsection does not apply to the issuance or renewal of an**
 12 **operator's license that contains an expiration date after 2012.**

13 (b) Except as provided in sections 10, 11, and 12 of this chapter, an
 14 operator's license issued to an applicant who is at least seventy-five
 15 (75) years of age expires at midnight of the birthday of the holder that
 16 occurs three (3) years following the date of issuance.

17 (c) Except as provided in subsections **(a)**, **(b)**, ~~and~~ **(d)**, and **(f) and**
 18 sections 10, 11, and 12 of this chapter, an operator's license issued
 19 under this article expires at midnight of the birthday of the holder that
 20 occurs six (6) years following the date of issuance.

21 (d) A probationary operator's license issued under IC 9-24-11-3
 22 expires at ~~midnight of the twenty-first birthday of the holder.~~ **in**
 23 **accordance with IC 9-24-11-3(e).**

24 (e) A probationary **operator's** license issued under IC 9-24-11-3.3
 25 to an individual who complies with IC 9-24-9-2.5(5) through
 26 IC 9-24-9-2.5(9) expires:

27 (1) at midnight one (1) year after issuance if there is no expiration
 28 date on the authorization granted to the individual to remain in the
 29 United States; or

30 (2) if there is an expiration date on the authorization granted to
 31 the individual to remain in the United States, the earlier of the
 32 following:

33 (A) At midnight of the date the authorization to remain in the
 34 United States expires.

35 (B) At midnight of the date thirty (30) days after the
 36 twenty-first birthday of the holder.

37 (f) Except as provided in subsection (e), a probationary operator's
 38 license issued under IC 9-24-11-3.3 expires at midnight of the date

1 thirty (30) days after the twenty-first birthday of the holder."
2 Page 3, delete lines 1 through 9, begin a new paragraph and insert:
3 **"(c) Notwithstanding subsection (a), the fee for the renewal of an**
4 **operator's license issued under IC 9-24 that contains a 2012**
5 **expiration date is as follows:**
6 **(1) If the license was previously issued or renewed after May**
7 **14, 2007, and before January 1, 2008, the fee is seven dollars**
8 **and fifty cents (\$7.50).**
9 **(2) If the license was previously issued or renewed after**
10 **December 31, 2007, and before January 1, 2009, the fee is nine**
11 **dollars (\$9).**
12 **(3) If the license was previously issued or renewed after**
13 **December 31, 2005, and before January 1, 2007, the fee is six**
14 **dollars (\$6)."**
