### MR. SPEAKER:

*Your Committee on Public Health, to which was referred Senate Bill 15, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Delete the title and insert the following:
- 2 A BILL FOR AN ACT to amend the Indiana Code concerning
- 3 human services.
- 4 Page 1, line 1, after "1." insert "IC 12-15-1.3-18 IS ADDED TO
- 5 THE INDIANA CODE AS A **NEW SECTION TO READ AS**
- 6 **FOLLOWS**".
- 7 Page 1, line 1, delete "PASSAGE]" and insert "PASSAGE]: **Sec.**
- 8 **18.**".
- 9 Page 1, line 1, delete "state" and insert "**office shall do the**
- 10 **following:**
- 11 **(1) Before September 1, 2012, apply to the United States**
- 12 **Department of Health and Human Services for an amendment**
- 13 **to the state Medicaid plan to include reimbursement under**
- 14 **Medicaid for brain injury services and neurobehavioral**
- 15 **services provided in Indiana.**".

1 Page 1, delete lines 2 through 11.

2 Page 1, line 12, delete "(1) Development of", begin a new line block  
3 indented and insert:

4 **"(2) Provide the state department of health with information**  
5 **necessary for the state department of health to create".**

6 Page 1, line 13, delete "the criteria to be included for the" and insert  
7 **"facilities that provide brain injury services."**

8 Page 1, delete lines 14 through 18, begin a new paragraph and  
9 insert:

10 **"(b) The state department of health shall license facilities that**  
11 **provide brain injury services and neurobehavioral services and**  
12 **shall consider the information provided by the office under**  
13 **subsection (a)(2).**

14 **(c) The office may not implement the Medicaid plan amendment**  
15 **under subsection (a) until the office files an affidavit with the**  
16 **governor attesting that the Medicaid plan amendment applied for**  
17 **under subsection (a) is in effect. The office shall file the affidavit**  
18 **under this subsection not later than five (5) days after the office is**  
19 **notified that the Medicaid plan amendment is approved.**

20 **(d) If the office receives a plan amendment under this section**  
21 **from the United States Department of Health and Human Services**  
22 **and the governor receives the affidavit filed under subsection (c),**  
23 **the office shall implement the Medicaid plan amendment under**  
24 **subsection (a) not more than sixty (60) days after the governor**  
25 **receives the affidavit.**

26 **(e) The office may adopt rules under IC 4-22-2 necessary to**  
27 **implement this section.**

28 **(f) The office shall provide the health finance commission**  
29 **(established by IC 2-5-23-3) with an update on the status and**  
30 **implementation of this section during the 2012 and 2013 legislative**  
31 **interims."**

32 Page 2, delete lines 1 through 17.

33 Page 2, line 18, delete "(d)" and insert "(g)".

34 Page 2, line 18, after "treatment" insert "advisory".

35 Page 2, line 20, delete "study" and insert **"implementation of this**  
36 **section."**

37 Page 2, line 21, delete "required under this SECTION".

38 Page 3, line 3, delete "IC 25-33 who" and insert **"IC 25-33-1 who**

- 1 specializes in the assessment and treatment of individuals with a  
 2 brain injury."  
 3 Page 3, delete line 4.  
 4 Page 3, between lines 6 and 7, begin a new line double block  
 5 indented and insert:  
 6 **"(G) One (1) representative of the Indiana Association of Area**  
 7 **Agencies on Aging."**  
 8 Page 3, line 7, delete "state department of health" and insert  
 9 "office".  
 10 Page 3, line 11, after "duties." insert "**The committee is abolished**  
 11 **July 1, 2013."**  
 12 Page 3, delete line 12, begin a new paragraph and insert:  
 13 "SECTION 2. [EFFECTIVE JULY 1, 2012] **(a) The office of**  
 14 **Medicaid policy and planning (IC 12-8-6-1) shall develop a plan for**  
 15 **a pilot program to establish a case management system for aged,**  
 16 **blind, and disabled Medicaid recipients.**  
 17 **(b) Before September 29, 2012, the office of Medicaid policy and**  
 18 **planning shall submit the plan developed under subsection (a),**  
 19 **including any proposed legislative changes needed to implement**  
 20 **the plan, to the health finance commission (established by**  
 21 **IC 2-5-23-3).**  
 22 **(c) The health finance commission shall study whether:**  
 23 **(1) the plan developed under subsection (a) should be**  
 24 **implemented; and**  
 25 **(2) legislation should be prepared concerning the plan**  
 26 **developed under this SECTION.**  
 27 **(d) This SECTION expires December 31, 2012."**  
 28 Renumber all SECTIONS consecutively.  
 (Reference is to SB 15 as reprinted January 18, 2012.)
