- 26 **under IC 31-34-1-6; and**
- 27 **(2) the unmet mental health needs of children within the**
- 28 **juvenile justice system, including children in need of services**
- 29 **and delinquent children.**
- 30 **(c) The committee shall operate under the policies governing**
- 31 **study committees adopted by the legislative council.**
- 32 **(d) The committee consists of the following members:**
- 33 **(1) Four (4) senators appointed by the president pro tempore**
- 34 **of the senate in consultation with the minority leader of the**
- 35 **senate, not more than two (2) of whom may be members of the**
- 36 **same political party.**
- 37 **(2) Four (4) representatives appointed by the speaker of the**
- 38 **house of representatives in consultation with the minority**

- 1 leader of the house of representatives, not more than two (2)
- 2 of whom may be members of the same political party.
- 3 (3) The chairperson of the juvenile justice improvement
- 4 committee.
- 5 (4) The president of the Indiana council of juvenile and family
- 6 court judges.
- 7 (5) The director of the department of child services or the
- 8 director's designee.
- 9 (6) The director of the division of mental health and addiction
- 10 or the director's designee.
- 11 (7) The executive director of the prosecuting attorneys council
- 12 or the executive director's designee.
- 13 (8) The executive director of the public defenders council or
- 14 the executive director's designee.
- 15 (9) The state superintendent of public instruction or the state
- 16 superintendent's designee.
- 17 (10) The commissioner of the department of correction or the
- 18 commissioner's designee.
- 19 (e) The affirmative votes of a majority of the members of the
- 20 committee are required for the committee to take action on any
- 21 measure, including final reports.
- 22 (f) This SECTION expires December 31, 2013."
- 23 Renumber all SECTIONS consecutively.
