

SENATE BILL No. 307

DIGEST OF INTRODUCED BILL

Citations Affected: IC 36-8-19-6.

Synopsis: Fire protection territories. Codifies and makes permanent certain additional public hearing and information requirements that must be satisfied before the legislative body of a local unit can adopt an ordinance or a resolution to form a fire protection territory. (These additional requirements were enacted in P.L.172-2011, but under current law they are temporary and will expire on June 30, 2012.) Repeals the temporary provision.

Effective: Upon passage.

A BILL FOR AN ACT to amend the Indiana Code concerning taxation.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 36-8-19-6, AS AMENDED BY P.L.47-2007,
- 2 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 3 UPON PASSAGE]: Sec. 6. (a) To establish a fire protection territory,
- 4 the legislative bodies of each unit desiring to become a part of the
- 5 proposed territory must adopt an ordinance (if the unit is a county or
- 6 municipality) or a resolution (if the unit is a township) that meets the
- 7 following requirements:
- 8 (1) The ordinance or resolution is identical to the ordinances and
- 9 resolutions adopted by the other units desiring to become a part
- 10 of the proposed territory.
- 11 (2) The ordinance or resolution is adopted after January 1 but
- 12 before April 1.
- 13 (3) The ordinance or resolution authorizes the unit to become a
- 14 party to an agreement for the establishment of a fire protection
- 15 territory.
- 16 (4) The ordinance or resolution is adopted after the legislative
- 17 body holds a public hearing to receive public comment on the



1 proposed ordinance or resolution. The legislative body must give
2 notice of the hearing under IC 5-3-1.

3 **(b) Before the legislative body of a unit may adopt an ordinance**
4 **or a resolution under this section to form a territory, the legislative**
5 **body must hold a public hearing, at least thirty (30) days before**
6 **adopting the ordinance or resolution, at which the legislative body**
7 **makes available to the public the following information:**

8 **(1) The property tax levy, property tax rate, and budget to be**
9 **imposed or adopted during the first year of the proposed**
10 **territory for each of the units that would participate in the**
11 **proposed territory.**

12 **(2) The estimated effect of the proposed reorganization in the**
13 **following years on taxpayers in each of the units that would**
14 **participate in the proposed territory, including the expected**
15 **property tax rates, property tax levies, expenditure levels,**
16 **service levels, and annual debt service payments.**

17 **(3) The estimated effect of the proposed reorganization on**
18 **other units in the county in the following years and on local**
19 **option income taxes, excise taxes, and property tax circuit**
20 **breaker credits.**

21 **(4) A description of the planned services and staffing levels to**
22 **be provided in the proposed territory.**

23 **(5) A description of any capital improvements to be provided**
24 **in the proposed territory.**

25 **The public hearing required under this subsection is in addition to**
26 **the public hearing required under subsection (a)(4).**

27 ~~(b)~~ **(c) The notice required under this section shall include all of the**
28 **following:**

29 **(1) A list of the provider unit and all participating units in the**
30 **proposed territory.**

31 **(2) The date, time, and location of the hearing.**

32 **(3) The location where the public can inspect the proposed**
33 **ordinance or resolution.**

34 **(4) A statement as to whether the proposed ordinance or**
35 **resolution requires uniform tax rates or different tax rates within**
36 **the territory.**

37 **(5) The name and telephone number of a representative of the unit**
38 **who may be contacted for further information.**

39 **(6) The proposed levies and tax rates for each participating**
40 **unit.**

- 1 (1) The boundaries of the proposed territory.
- 2 (2) The identity of the provider unit and all other participating
- 3 units desiring to be included within the territory.
- 4 (3) An agreement to impose:
- 5 (A) a uniform tax rate upon all of the taxable property within
- 6 the territory for fire protection services; or
- 7 (B) different tax rates for fire protection services for the units
- 8 desiring to be included within the territory, so long as a tax
- 9 rate applies uniformly to all of a unit's taxable property within
- 10 the territory.
- 11 (4) The contents of the agreement to establish the territory.

12 ~~(d)~~ (e) An ordinance or a resolution adopted under this section takes
 13 effect July 1 of the year the ordinance or resolution is adopted.

14 SECTION 2. P.L.172-2011, SECTION 163, IS REPEALED
 15 [EFFECTIVE UPON PASSAGE]. SECTION 163: (a) In addition to
 16 any other requirements under IC 36-8-19-6(a), before the legislative
 17 body of a unit that desires to become part of a fire protection territory
 18 may adopt an ordinance or a resolution to form a territory, the
 19 legislative body of the unit must (notwithstanding IC 36-8-19-6(a)) do
 20 the following:

21 (1) Hold a public hearing at least thirty (30) days before adopting
 22 an ordinance or a resolution to form a territory at which the
 23 legislative body makes available to the public the following
 24 information:

25 (A) The property tax levy, property tax rate, and budget to be
 26 imposed or adopted during the first year of the territory for
 27 each of the units that would participate in the proposed fire
 28 protection territory:

29 (B) The estimated effect of the proposed reorganization in the
 30 following years on taxpayers in each of the units that would
 31 participate in the proposed fire protection territory, including
 32 the expected property tax rates, property tax levies,
 33 expenditure levels, service levels, and annual debt service
 34 payments:

35 (C) The estimated effect of the proposed reorganization to
 36 other units in the county in the following years and to local
 37 option income taxes, excise taxes, and property tax circuit
 38 breaker credits:

39 (D) A description of the planned services and staffing levels
 40 to be provided in the proposed fire protection territory:

41 (E) A description of any capital improvements to be provided
 42 in the proposed fire protection territory:

1 (2) Hold at least one (1) additional public hearing before adopting
2 an ordinance or a resolution to form a territory to receive public
3 comment on the proposed ordinance or resolution.
4 The legislative body must give notice of the hearings under IC 5-3-1.
5 (b) In addition to the information required by IC 36-8-19-6(b); the
6 notice required under that section must include the proposed levies and
7 tax rates for each participating unit.
8 (c) This SECTION expires June 30, 2012.
9 **SECTION 3. An emergency is declared for this act.**
