
HOUSE BILL No. 1180

DIGEST OF INTRODUCED BILL

Citations Affected: IC 16-20-1-27; IC 16-22-8-34.3; IC 16-41-25.5.

Synopsis: Soil and septic system education and research. Establishes the soil and septic system education and research council (council). Requires the dean of agriculture of Purdue University to establish and administer a soil and septic system education and research program. Establishes the soil and septic system education and research fund (fund). Provides that the council shall recommend expenditures from the fund for the soil and septic system education and research program. Requires the board of each county health department (and the Marion County health and hospital corporation) to impose a fee of \$25 on each permit issued by the county health department or the county for the operation, installation, construction, repair, or replacement of a septic system. Requires 80% of the fees to be paid to the treasurer of state for distribution to the fund and 20% of the fees to be placed into the county health fund for education and outreach activities related to soils and septic systems.

Effective: July 1, 2012.

HOUSE BILL No. 1180



A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 16-20-1-27 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 2012]: Sec. 27. **(a)** The board of
3 each local health department may, with the approval of the county or
4 city executive, establish and collect fees for specific services and
5 records established by local ordinances and state law. However, fees
6 may not exceed the cost of services provided. The fees shall be
7 accounted for and transferred to the health fund of the taxing
8 jurisdiction.

9 **(b) In addition to any other fees imposed under subsection (a),**
10 **the board of each county health department shall impose a fee of**
11 **twenty-five dollars (\$25) on each permit issued by the county**
12 **health department or the county for the operation, installation,**
13 **construction, repair, or replacement of a septic system.**

14 **(c) Eighty percent (80%) of any fees collected under subsection**
15 **(b) shall be paid by the county treasurer to the treasurer of state**
16 **not later than the fifteenth day of the month following the month**
17 **in which the fees are collected. The treasurer of state shall transfer**



1 fees received under this subsection to the soil and septic system
 2 education and research fund established by IC 16-41-25.5-7. The
 3 treasurer of state shall transfer the fees to the soil and septic
 4 system education and research fund not later than the fifteenth day
 5 of the month following the month in which the treasurer of state
 6 receives the fees.

7 (d) Twenty percent (20%) of any fees collected under subsection
 8 (b) shall be deposited by the county treasurer into an account
 9 within the county health fund not later than the fifteenth day of the
 10 month following the month in which the fees are collected. Money
 11 in the account may be used only for education and outreach
 12 activities related to soils and septic systems.

13 SECTION 2. IC 16-22-8-34.3 IS ADDED TO THE INDIANA
 14 CODE AS A NEW SECTION TO READ AS FOLLOWS
 15 [EFFECTIVE JULY 1, 2012]: Sec. 34.3. (a) In addition to any other
 16 fees imposed by the board or the corporation, the board shall
 17 impose a fee of twenty-five dollars (\$25) on each permit issued by
 18 the corporation or the county for the operation, installation,
 19 construction, repair, or replacement of a septic system.

20 (b) Eighty percent (80%) of any fees collected under subsection
 21 (a) shall be paid by the county treasurer to the treasurer of state
 22 not later than the fifteenth day of the month following the month
 23 in which the fees are collected. The treasurer of state shall transfer
 24 fees received under this subsection to the soil and septic system
 25 education and research fund established by IC 16-41-25.5-7. The
 26 treasurer of state shall transfer the fees to the soil and septic
 27 system education and research fund not later than the fifteenth day
 28 of the month following the month in which the treasurer of state
 29 receives the fees.

30 (c) Twenty percent (20%) of any fees collected under subsection
 31 (a) shall be deposited by the county treasurer into an account
 32 within the county health fund not later than the fifteenth day of the
 33 month following the month in which the fees are collected. Money
 34 in the account may be used only for education and outreach
 35 activities related to soils and septic systems.

36 SECTION 3. IC 16-41-25.5 IS ADDED TO THE INDIANA CODE
 37 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
 38 JULY 1, 2012]:

39 **Chapter 25.5. Soil and Septic System Education and Research**

40 **Sec. 1.** As used in this chapter, "council" refers to the soil and
 41 septic system education and research council created by this
 42 chapter.

1 **Sec. 2.** As used in this chapter, "director" refers to the dean of
2 agriculture of Purdue University or the dean's designee.

3 **Sec. 3.** The director shall establish and administer a soil and
4 septic system education and research program.

5 **Sec. 4.** The soil and septic system education and research
6 program may include research, education, and outreach activities
7 related to soils and septic systems.

8 **Sec. 5.** The director may contract with a qualified organization,
9 agency, or individual to perform any part of the soil and septic
10 system education and research program, including any of the
11 activities described in section 4 of this chapter.

12 **Sec. 6.** The director may not regulate:

- 13 (1) septic systems or septic system components;
14 (2) residential or commercial wastewater treatment systems;
15 or
16 (3) the price of any system (or component of a system)
17 described in subdivision (1) or (2);

18 under this chapter.

19 **Sec. 7. (a)** The soil and septic system education and research
20 fund is established. The fund consists of the following:

- 21 (1) Fees deposited in the fund under IC 16-20-1-27 or
22 IC 16-22-8-34.3.
23 (2) Any appropriations made to the fund by the general
24 assembly.
25 (3) Any gifts or grants made to the fund.

26 **(b)** The fund may not be used for political or legislative activity
27 of any kind.

28 **(c)** The fund shall be administered by the director and used for
29 purposes of this chapter. The expenses of administering the fund
30 shall be paid from money in the fund.

31 **(d)** Money in the fund at the end of a state fiscal year does not
32 revert to the state general fund.

33 **Sec. 8. (a)** The soil and septic system education and research
34 council is created.

35 **(b)** The council must have an odd number of members, but at
36 least five (5) and not more than nine (9) members. The following
37 are members of the council:

- 38 (1) The director or the director's designee.
39 (2) The head of the agricultural and biological engineering
40 department at Purdue University or the designee of the head
41 of the department.
42 (3) The director of the Indiana water resources research

- 1 center at Purdue University or the designee of the director of
- 2 the center.
- 3 (4) The head of the agronomy department at Purdue
- 4 University or the designee of the head of the department.
- 5 (5) The president of the Indiana Onsite Wastewater
- 6 Professionals Association or the designee of the president of
- 7 the association.
- 8 (6) Other members that the director shall appoint.
- 9 (c) A majority of the members of the council must have
- 10 expertise in at least one (1) of the following:
- 11 (1) Siting of septic systems.
- 12 (2) Design of septic systems.
- 13 (3) Installation of septic systems.
- 14 (4) Regulation of septic systems by local government.
- 15 (5) Maintenance of septic systems.
- 16 (6) Development of septic system components.
- 17 Sec. 9. The council shall adopt bylaws governing the terms of
- 18 office, filling unexpired terms, expenses, quorum, duties, and other
- 19 administrative matters. The bylaws may be amended by a
- 20 two-thirds (2/3) vote of the members present, if a quorum is
- 21 present.
- 22 Sec. 10. The council shall do the following:
- 23 (1) Elect a chairperson and any other officers.
- 24 (2) Recommend expenditures from the soil and septic system
- 25 education and research fund:
- 26 (A) for the soil and septic system education and research
- 27 program; and
- 28 (B) for the administration of this chapter.
- 29 (3) Perform any other necessary duties.
- 30 Sec. 11. The director shall consider the advice,
- 31 recommendations, and assistance of the council for the expenditure
- 32 of funds for the soil and septic system education and research
- 33 program and for the administration of this chapter.
