## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 4-13.6-6-5; IC 5-13-8-14; IC 5-16-1-9; IC 5-22-16.5; IC 5-23-1-5; IC 8-23-9-59; IC 21-37-7; IC 36-1-12-23.

**Synopsis:** Contracting with persons that invest in Iran. Provides that agencies of state government, state educational institutions, and political subdivisions may not enter into contracts with persons that engage in investment activities in Iran. Provides that a financial institution may not be designated as a public depository if the financial institution engages in investment activities in Iran. Requires the department of administration, using credible information available to the public, to establish a list of persons who engage in investment activities in Iran. Provides for the inclusion of persons on the list and the removal of persons from the list.

**Effective:** July 1, 2012.

A BILL FOR AN ACT to amend the Indiana Code concerning state and local administration.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 4-13.6-6-5 IS ADDED TO THE INDIANA CODE

 32           **Sec. 1. This chapter does not apply if federal law ceases to**  
 33 **authorize the states to adopt and enforce provisions relating to**  
 34 **public contracting such as those in this chapter.**  
 35           **Sec. 2. As used in this chapter, "department" refers to the**  
 36 **Indiana department of administration created by IC 4-13-1-2.**  
 37           **Sec. 3. As used in this chapter, "energy sector of Iran" includes**  
 38 **any activity to develop petroleum or natural gas resources or**  
 39 **nuclear power in Iran.**  
 40           **Sec. 4. As used in this chapter, "financial institution" has the**  
 41 **meaning set forth in Section 14 of the Iran Sanctions Act of 1996**  
 42 **(Public Law 104-172, 50 U.S.C. 1701 note), as in effect on January**

2 **Sec. 5.** As used in this chapter, "Iran" includes the government  
3 of Iran and any agency or instrumentality of the government of  
4 Iran.

5 **Sec. 6.** As used in this chapter, "list" refers to the list developed  
6 under section 9 of this chapter.

7 **Sec. 7.** For purposes of this chapter, "person" includes a  
8 successor to, or an affiliate of, the person.

9 **Sec. 8. (a)** For purposes of this chapter, a person engages in  
10 investment activities in Iran if either of the following is true:

11 (1) The person provides goods or services of twenty million  
12 dollars (\$20,000,000) or more in value in the energy sector of  
13 Iran, including providing any of the following for the energy  
14 sector of Iran:

15 (A) Oil or liquified natural gas tankers.

16 (B) Products used to construct or maintain pipelines used  
17 to transport oil or liquified natural gas.

18 (2) The person is a financial institution that extends twenty  
19 million dollars (\$20,000,000) or more in credit to another  
20 person, for forty-five (45) days or more, if that other person:

21 (A) will use the credit to provide goods or services in the  
22 energy sector in Iran; and

23 (B) is a person identified on the list as a person engaging in  
24 investment activities in Iran under subdivision (1).

25 (b) A person's investment contract with the Indiana public  
26 retirement system may not be used as the basis for making a  
27 determination under this chapter that the person is engaged in  
28 investment activities in Iran.

29 **Sec. 9. (a)** Not later than July 1, 2012, the department, using  
30 credible information available to the public, shall develop a list of  
31 persons the department determines to be engaged in investment  
32 activities in Iran.

33 (b) The department may enter into contracts for the  
34 development of the list.

35 (c) The list must be updated not later than every one hundred  
36 eighty (180) days.

37 (d) The department shall publish the list on the department's  
38 Internet web site.

39 (e) The department shall make every effort to avoid erroneous  
40 inclusion of a person on the list.

41 **Sec. 10. (a)** Before the department publishes the list under  
42 section 9 of this chapter, the department shall do the following:

1 (1) Provide ninety (90) days' advance written notice to any  
 2 person of the department's intent to include that person on  
 3 the list. The notice required by this subdivision must include  
 4 the following information:

5 (A) A statement that a person's inclusion on the list would  
 6 make the person nonresponsible for purposes of:

- 7 (i) submitting an offer in response to a solicitation;  
 8 (ii) submitting a bid, offer, or proposal relating to a  
 9 public works project; or  
 10 (iii) otherwise entering into or renewing a contract to  
 11 provide supplies or services;

12 with the state or a political subdivision.

13 (B) A statement that the person will be removed from the  
 14 list if the person ceases engaging in investment activities in  
 15 Iran.

16 (C) A statement that the person's status as nonresponsible  
 17 with respect to this chapter ends when the person's name  
 18 is removed from the list.

19 (2) Provide a person that is to be placed on the list an  
 20 opportunity to demonstrate in writing to the department that  
 21 the person is not engaged in investment activities in Iran.

22 (b) If a person demonstrates to the department that the person  
 23 is not engaged in investment activities in Iran, the department may  
 24 not include the person on the list.

25 Sec. 11. (a) Except as provided in section 12 of this chapter, a  
 26 person that is placed on the list is considered nonresponsible for  
 27 purposes of:

- 28 (1) submitting an offer in response to a solicitation;  
 29 (2) submitting a bid, offer, or proposal relating to a public  
 30 works project; or  
 31 (3) otherwise entering into or renewing a contract to provide  
 32 supplies or services;

33 with the state or a political subdivision.

34 (b) Except as provided in section 12 of this chapter, a person's  
 35 status as nonresponsible under this chapter ends when the person's  
 36 name is removed from the list.

37 Sec. 12. (a) Section 11 of this chapter does not apply to the  
 38 award of a particular contract to a person if subdivision (1) or (2)  
 39 applies:

40 (1) The purchasing agency awarding the contract finds in  
 41 writing that all of the following are true:

- 2 (B) The person's investment activities in Iran have not  
3 been expanded or renewed after July 1, 2012.
- 4 (C) The purchasing agency determines that it is in the best  
5 interest of the purchasing agency's governmental body to  
6 enter into the contract with the person.
- 7 (D) The person has adopted and publicized and is  
8 implementing a formal plan to:
- 9 (i) cease investment activities in Iran; and  
10 (ii) refrain from engaging in any new investments in  
11 Iran.
- 12 (2) Either of the following applies:
- 13 (A) If the governmental body awarding the contract is a  
14 political subdivision, the executive of the political  
15 subdivision makes a written finding that the governmental  
16 body would be unable to obtain the supplies or services for  
17 which the solicitation is made unless a contract is awarded  
18 to the person.
- 19 (B) If the governmental body is a state agency, the  
20 governor makes a finding that the state would be unable to  
21 obtain the supplies or services for which the solicitation is  
22 made unless a contract is awarded to the person.
- 23 (b) A finding made under subsection (a) must be in writing and  
24 shall be placed in the contract file.
- 25 Sec. 13. (a) This section does not apply if a finding made under  
26 section 12 of this chapter is placed in the contract file.
- 27 (b) At the time a contract is awarded or renewed, the person  
28 that is being awarded or has the contract must certify in writing to  
29 the governmental body awarding or renewing the contract that the  
30 person is not engaged in investment activities in Iran.
- 31 (c) The certification required by this section shall be placed in  
32 the contract file.
- 33 Sec. 14. (a) If a purchasing agency, using credible information  
34 available to the public, determines that a certification given by a  
35 person to the purchasing agency's governmental body under  
36 section 13(b) of this chapter is false, the purchasing agency shall:
- 37 (1) notify the person in writing of the purchasing agency's  
38 determination that the certification is false; and
- 39 (2) give the person ninety (90) days within which to respond  
40 to the written notice.
- 41 (b) If the person fails to demonstrate to the purchasing agency  
42 that the person has ceased the person's investment activities in Iran

1 within ninety (90) days after the notice is given to the person under  
2 subsection (a), the following apply:

3 (1) The purchasing agency shall report to the attorney general  
4 the following:

5 (A) The name of the person that the purchasing agency has  
6 determined to have submitted a false certification.

7 (B) The information upon which the purchasing agency has  
8 made its determination.

9 The attorney general shall determine whether to bring a civil  
10 action under this section against the person.

11 (2) If the purchasing agency is a political subdivision, the  
12 purchasing agency may also provide the information  
13 described in subdivision (1) to an attorney representing the  
14 political subdivision. An attorney representing the political  
15 subdivision may bring a civil action under this section against  
16 the person if the attorney general declines to bring a civil  
17 action against the person under this chapter.

18 (3) If it is determined in a civil action under this section that  
19 the person submitted a false certification, the following apply:

20 (A) The court may impose on the person a civil penalty of  
21 two hundred fifty thousand dollars (\$250,000).

22 (B) The person shall pay all reasonable costs incurred in  
23 the action, including the following:

24 (i) Costs incurred by the governmental body in the  
25 investigations that led to the purchasing agency's finding  
26 that the person filed a false certification.

27 (ii) Reasonable attorney's fees and other litigation costs  
28 incurred by the governmental body.

29 (C) The purchasing agency may terminate the contract  
30 with the governmental body with respect to which the false  
31 certification was made.

32 (D) The purchasing agency may consider the person  
33 nonresponsible for purposes of the awarding of any  
34 contracts by the governmental body for not more than  
35 three (3) years after the date of the purchasing agency's  
36 determination under subsection (a).

37 (c) A civil action brought under this section must be filed not  
38 later than three (3) years after the purchasing agency makes the  
39 determination under subsection (a).

40 (d) A person other than the governmental body, including an  
41 unsuccessful offeror, may not:

42 (1) bring a civil action under this section;
