

SENATE MOTION

MADAM PRESIDENT:

I move that Senate Bill 257 be amended to read as follows:

- 1 Page 243, between lines 40 and 41, begin a new paragraph and
2 insert:
3 "SECTION 510. [EFFECTIVE UPON PASSAGE] (a) **As used in**
4 **this SECTION, "bureau" refers to the bureau of motor vehicles**
5 **created under IC 9-14-1-1.**
6 **(b) Notwithstanding IC 9-24-11-4, an individual who:**
7 **(1) held a validated temporary motorcycle learner's permit as**
8 **of December 31, 2011 (issued under IC 9-24-8-2 before its**
9 **repeal); and**
10 **(2) is not eligible for a motorcycle endorsement under**
11 **IC 9-24-8-4(b) because the individual is less than sixteen (16)**
12 **years and one hundred eighty (180) days of age;**
13 **is authorized to operate a motorcycle under the terms and**
14 **conditions of IC 9-24-8-2 (before its repeal) until the individual**
15 **qualifies for the validation of an operator's license for motorcycle**
16 **operation upon a highway by endorsement under IC 9-24-8-4(a) or**
17 **December 31, 2013, whichever is earlier.**
18 **(c) An individual who is authorized to operate a motorcycle**
19 **under a validated temporary motorcycle learner's permit under**
20 **subsection (b) may only operate a motorcycle under the following**
21 **conditions:**
22 **(1) The individual must wear a helmet that meets the**
23 **standards established by the United States Department of**
24 **Transportation under 49 CFR 571.218 as in effect January 1,**
25 **1979.**
26 **(2) The motorcycle may be operated only during daylight**
27 **hours.**
28 **(3) The motorcycle may not carry passengers other than the**
29 **operator.**
30 **(4) The individual must be under the supervision of a licensed**

- 1 **motorcycle operator who must be at least eighteen (18) years**
- 2 **of age.**
- 3 **(d) The bureau shall accept the certification by the instructor of**
- 4 **an approved motorcycle driver education and training course (as**
- 5 **the term was defined on December 31, 2011) that the individual**
- 6 **had passed the written test under IC 9-24-8-2(b) (before its repeal)**
- 7 **for purposes of the written test required under IC 9-24-8-4(a)**
- 8 **required for validation of an operator's license for motorcycle**
- 9 **operation by endorsement.**
- 10 **(e) IC 9-24-8-4(c) applies to the issuance of a license**
- 11 **endorsement for validation of an operator's license for motorcycle**
- 12 **operation.**
- 13 **(f) The bureau shall:**
- 14 **(1) identify each individual who, according to the records of**
- 15 **the bureau, was included in the category of individuals**
- 16 **described in subsection (b) as of December 31, 2011, and who**
- 17 **continues to be included in subsection (b); and**
- 18 **(2) reissue a validated temporary motorcycle learner's permit**
- 19 **(as issued under IC 9-24-8-2 before its repeal) if the individual**
- 20 **desires a reissuance of the validated temporary motorcycle**
- 21 **learner's permit.**
- 22 **The bureau shall reissue the validated temporary motorcycle**
- 23 **learner's permit without cost to the individual.**
- 24 **(g) This SECTION expires December 31, 2013."**
