

# SENATE MOTION

**MADAM PRESIDENT:**

**I move** that Senate Bill 327 be amended to read as follows:

- 1           Page 5, between lines 12 and 13, begin a new paragraph and insert:  
2           "SECTION 15. IC 9-18-25-1.7, AS AMENDED BY P.L.2-2005,  
3           SECTION 32, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
4           JANUARY 1, 2012 (RETROACTIVE)]; Sec. 1.7. Section ~~15~~ **15.5** of  
5           this chapter does not apply to a:  
6                 **(1) college or university; or**  
7                 **(2) military;**  
8           special group recognition license plate."  
9           Page 5, line 14, delete "JULY 1, 2012];" and insert "UPON  
10           PASSAGE];".  
11           Page 5, line 30, strike "may design and issue a special group  
12           recognition".  
13           Page 5, strike lines 31 through 32.  
14           Page 5, line 33, delete "or is otherwise eligible to purchase the plate  
15           of,".  
16           Page 5, line 33, strike "the special group." and insert "**shall**  
17           **forward:**  
18                 **(1) the application submitted under this section;**  
19                 **(2) the information secured by the bureau leading to the**  
20                 **approval under this subsection; and**  
21                 **(3) any other information that the bureau considers**  
22                 **necessary;**  
23           **to the general assembly to provide information for creating an**  
24           **introduced bill for the next general session of the general assembly**  
25           **that will authorize the inclusion of the special group in the special**  
26           **group recognition license plate program."**  
27           Page 6, delete lines 30 through 42, begin a new paragraph and  
28           insert:  
29           "SECTION 20. IC 9-18-25-15 IS REPEALED [EFFECTIVE  
30           JANUARY 1, 2012 (RETROACTIVE)]. ~~Sec. 15. The bureau shall~~

1 terminate an organization's qualification for the special group license  
 2 plate program and no further special group recognition license plates  
 3 shall be issued for an organization if less than two thousand (2,000) of  
 4 the organization's special group license plates are sold or renewed in  
 5 the first four (4) years of the five (5) year period beginning the earlier  
 6 of January 1, 2002; or January 1 of the year in which the organization's  
 7 special group license plate is first issued. The bureau shall reevaluate  
 8 the organization's qualification for the special group license plate  
 9 program every five (5) years thereafter. The bureau shall terminate the  
 10 organization's qualification for the special group license plate program  
 11 and no further special group recognition license plates shall be issued  
 12 for an organization if less than two thousand (2,000) of the  
 13 organization's special group license plates are sold or renewed in the  
 14 first four (4) years of a subsequent five (5) year period."

15 Page 7, delete lines 1 through 9, begin a new paragraph and insert:

16 "SECTION 21. IC 9-18-25-15.5 IS ADDED TO THE INDIANA  
 17 CODE AS A NEW SECTION TO READ AS FOLLOWS  
 18 [EFFECTIVE JANUARY 1, 2012 (RETROACTIVE)]: **Sec.15.5. (a)**  
 19 **Beginning January 1, 2012, at least one thousand (1,000) special**  
 20 **group recognition license plates must be sold on behalf of a special**  
 21 **group each calendar year. If fewer than one thousand (1,000)**  
 22 **special group recognition license plates are sold on behalf of a**  
 23 **special group in a calendar year, and during the subsequent**  
 24 **calendar year fewer than one thousand (1,000) special group**  
 25 **recognition license plates are sold on behalf of the special group,**  
 26 **the bureau shall terminate the special group's qualification for the**  
 27 **special group license plate program at the beginning of the third**  
 28 **calendar year.**

29 (b) If the bureau terminates a special group's qualification  
 30 under this section, no further special group recognition license  
 31 plates shall be issued for the special group unless:

- 32 (1) the special group reapplies under section 2 of this chapter;
- 33 (2) the special group again meets the requirements under
- 34 section 2 of this chapter; and
- 35 (3) a bill described in section 2(d) of this chapter is enacted by
- 36 the general assembly."

- 1 Page 11, after line 1, begin a new paragraph and insert:
- 2 "SECTION 26. **An emergency is declared for this act.**".
- 3 Renumber all SECTIONS consecutively.
