- 29 **to a study committee, for study during the 2012 legislative interim,**
- 30 **the topic of amending IC 3-5-9, as added by HEA1005-2012, to**

1 **apply the statute to:**
2 **(1) full-time paid firefighters serving in the fire department of**
3 **a unit; and**
4 **(2) volunteer firefighters serving in a department that**
5 **provides fire protection services to a unit.**
6 **(c) If the topic is assigned to an interim or statutory study**
7 **committee under subsection (a), the study committee shall issue a**
8 **final report to the legislative council containing the study**
9 **committee's findings and recommendations, including any**
10 **recommended legislation concerning the topic, not later than**
11 **November 1, 2012.**
12 **(d) This SECTION expires December 31, 2012.**
13 **SECTION 14. An emergency is declared for this act."**
14 Renumber all SECTIONS consecutively.
