

SENATE MOTION

MADAM PRESIDENT:

I move that Engrossed House Bill 1376 be amended to read as follows:

- 1 Page 2, between lines 14 and 15, begin a new line block indented
2 and insert:
3 **"(1) transfer:**
4 **(A) in 2013, the first sixteen million dollars (\$16,000,000)**
5 **of any excess reserves for that year to the prekindergarten**
6 **pilot program fund established under IC 20-20-35-10.5 for**
7 **purposes of making grants from the fund; and**
8 **(B) in 2014, the first twenty million dollars (\$20,000,000) of**
9 **any excess reserves for that year to the prekindergarten**
10 **pilot program fund established under IC 20-20-35-10.5 for**
11 **purposes of making grants from the fund;"**.
12 Page 2, line 15, delete "(1) If" and insert "**(2) If, after making the**
13 **transfer required under subdivision (1),"**.
14 Page 2, line 20, delete "(2) If" and insert "**(3) If, after making the**
15 **transfer required under subdivision (1),"**.
16 Page 28, between lines 30 and 31, begin a new paragraph and insert:
17 "SECTION 43. IC 20-20-35-1, AS ADDED BY P.L.234-2007,
18 SECTION 62, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
19 JULY 1, 2012]: Sec. 1. As used in this chapter, "eligible provider"
20 means any of the following:
21 (1) School corporations.
22 (2) Any entity providing a prekindergarten program that is
23 accredited by the National Association for the Education of
24 Young Children.
25 However, the term does not include a charter school or an entity
26 affiliated with a charter school.
27 SECTION 44. IC 20-20-35-3, AS ADDED BY P.L.234-2007,
28 SECTION 62, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
29 JULY 1, 2012]: Sec. 3. (a) The department shall establish a pilot
30 program to provide grants to eligible providers selected by the

1 department to implement prekindergarten programs.
 2 (b) The department shall administer the pilot program.
 3 (c) **The department shall begin providing grants in the**
 4 **2013-2014 school year.**
 5 SECTION 45. IC 20-20-35-10.5 IS ADDED TO THE INDIANA
 6 CODE AS A NEW SECTION TO READ AS FOLLOWS
 7 [EFFECTIVE JULY 1, 2012]: **Sec. 10.5. (a) The prekindergarten**
 8 **pilot program fund is established. The money in the fund shall be**
 9 **used by the department for providing grants under section 3 of this**
 10 **chapter.**
 11 (b) **The department shall administer the fund.**
 12 (c) **The fund consists of:**
 13 (1) **transfers under IC 4-10-22-3;**
 14 (2) **appropriations from the general assembly; and**
 15 (3) **gifts and grants to the fund, including grants from private**
 16 **entities.**
 17 (d) **Money in the fund is annually appropriated to the**
 18 **department for the department's use in carrying out the purposes**
 19 **of this chapter.**
 20 (e) **Money in the fund at the end of a state fiscal year ending**
 21 **before July 1, 2020, does not revert to the state general fund. Any**
 22 **balance remaining in the fund on June 30, 2020, is transferred to**
 23 **the state general fund.**
 24 SECTION 46. IC 20-20-35-11, AS ADDED BY P.L.234-2007,
 25 SECTION 62, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 26 JULY 1, 2012]: Sec. 11. This chapter expires July 1, ~~2014~~ **2020**.
 27 Renumber all SECTIONS consecutively.
