

SENATE MOTION

MADAM PRESIDENT:

I move that Engrossed House Bill 1376 be amended to read as follows:

- 1 Page 1, delete lines 5 through 17, begin a new paragraph and insert:
2 "SECTION 2. IC 4-10-22 IS REPEALED [EFFECTIVE JANUARY
3 1, 2013]. (Use of Excess Reserves).".
4 SECTION 3. IC 4-10-22-1.1, IS ADDED TO THE INDIANA
5 CODE AS A NEW SECTION TO READ AS FOLLOWS
6 [EFFECTIVE UPON PASSAGE]: **Sec. 1.1 (a) Notwithstanding the**
7 **repeal of this chapter January 1, 2013, any automatic taxpayer**
8 **refund from 2012 shall be granted under the provisions of this**
9 **chapter as in effect on July 1, 2012.**
10 **(b) This section expires January 1, 2017."**
11 Page 2, delete lines 1 through 9.
12 Page 38, between lines 18 and 19, begin a new paragraph and insert:
13 "SECTION 55. [EFFECTIVE JULY 1, 2012] **(a) As used in this**
14 **SECTION, "school corporation" has the meaning set forth in**
15 **IC 20-43-1-23.**
16 **(b) In addition to the amounts appropriated in P.L.229-2011,**
17 **SECTION 9, for DISTRIBUTIONS FOR TUITION SUPPORT,**
18 **one hundred fifty million dollars (\$150,000,000) is appropriated for**
19 **the state fiscal year beginning July 1, 2012, and ending June 30,**
20 **2013, to make additional tuition support distributions to school**
21 **corporations during 2012.**
22 **(c) The total amount of the additional tuition support**
23 **distribution that a school corporation is entitled to receive under**
24 **this SECTION during 2012 is equal to the result determined under**
25 **STEP TWO of the following STEPS:**
26 **STEP ONE: Determine the result of:**
27 **(A) the tuition support distribution that would otherwise**
28 **be received in 2012 by the school corporation, without**
29 **considering the distributions made under this SECTION;**
30 **divided by**

- 1 **(B) the total amount of tuition support distributions that**
- 2 **would otherwise be received in 2012 by all school**
- 3 **corporations, without considering the distributions made**
- 4 **under this SECTION.**
- 5 **STEP TWO: Multiply the STEP ONE result by one hundred**
- 6 **fifty million dollars (\$150,000,000).**
- 7 **(d) The additional tuition support distribution that a school**
- 8 **corporation is entitled to receive under this SECTION shall be**
- 9 **made monthly in six (6) equal amounts during the last six (6)**
- 10 **months of 2012.**
- 11 **(e) In determining a school corporation's previous year revenue**
- 12 **under IC 20-43-3-4 for purposes of calculating the school**
- 13 **corporation's tuition support distributions under IC 20-43 for**
- 14 **2013, the amount distributed in 2012 to the school corporation as**
- 15 **an additional tuition support distribution under this SECTION**
- 16 **shall also be included in the school corporation's previous year**
- 17 **revenue.**
- 18 **(f) This SECTION expires January 1, 2015."**
- 19 Renumber all SECTIONS consecutively.
