

SENATE MOTION

MADAM PRESIDENT:

I move that Engrossed House Bill 1005 be amended to read as follows:

- 1 Page 1, line 2, delete "[EFFECTIVE JULY". and insert
2 "[EFFECTIVE JANUARY 1, 2013]".
3 Page 1, line 3, delete "1, 2012]".
4 Page 1, line 8, after "executive" insert "**or a member of the**
5 **executive body**".
6 Page 2, line 5, after "receives" insert "**fire protection**".
7 Page 2, delete lines 8 through 12, begin a new paragraph and insert:
8 "**(b) An individual who:**
9 **(1) is an employee of a unit, serving as a full-time, paid**
10 **firefighter; or**
11 **(2) serves as a volunteer firefighter;**
12 **in a department that provides fire protection services to more than**
13 **one (1) unit, excluding fire protection services provided under**
14 **mutual aid agreements, may not assume or hold an elected office**
15 **of any unit that receives fire protection services from the**
16 **department.**".
17 Page 2, delete lines 21 through 24, begin a new line block indented
18 and insert:
19 "**(2) a full-time, paid firefighter or volunteer firefighter from**
20 **assuming or holding an elected office of a unit other than a**
21 **unit that receives fire protection services from the department**
22 **in which the volunteer firefighter serves; or**".
23 Page 2, line 41, after "receives" insert "**fire protection**".
24 Page 3, delete lines 8 through 41, begin a new paragraph and insert:
25 "**SECTION 2. IC 5-11-13-1.1 IS ADDED TO THE INDIANA**
26 **CODE AS A NEW SECTION TO READ AS FOLLOWS**
27 **[EFFECTIVE JULY 1, 2012]: Sec. 1.1. (a) This section applies to a**
28 **unit (as defined in IC 36-1-2-23).**
29 **(b) A report under section 1 of this chapter that is submitted**
30 **after December 31, 2012, must include a statement by the executive**

1 (as defined in IC 36-1-2-5) of the unit regarding whether the unit
2 has implemented a policy under IC 36-1-20.2 and IC 36-1-21. If a
3 unit does not implement a policy under IC 36-1-20.2 and
4 IC 36-1-21, the department of local government finance may not
5 approve the unit's budget or any additional appropriations for the
6 unit for the ensuing calendar year."

7 Page 8, line 35, delete "the employment of a relative that is not" and
8 insert "**or restrict an individual from entering into a contract with**
9 **the unit that is not otherwise prohibited or restricted by this**
10 **chapter.**".

11 Page 8, delete line 36.

12 Page 12, line 23, strike "public employees' retirement fund." and
13 insert "**Indiana public retirement system.**".
