SENATE BILL No. 362

DIGEST OF SB 362 (Updated January 23, 2012 2:38 pm - DI 77)

Citations Affected: IC 14-13.

Synopsis: White River park foundation. Authorizes the White River state park development commission (commission) to establish a nonprofit subsidiary corporation to solicit and accept private funding. Provides that the voting members of the commission and any other directors that the commission appoints are the members of the board of accounts to annually audit the subsidiary corporation.

Effective: July 1, 2012.

SENATE BILL No. 362

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 14-13-1-41 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2012]: **Sec. 41. (a) The commission may establish a nonprofit
4 subsidiary corporation that is exempt from federal income taxation
5 under Section 501(c)(3) of the Internal Revenue Code, to solicit and
6 accept private funding, gifts, donations, bequests, devises, and
7 contributions.**
8 **(b) A subsidiary corporation established under this section:**
9 **(1) shall use money received under subsection (a) to carry out
10 in any manner the purposes of and programs under this
11 chapter;**
12 **(2) shall report to the budget committee each year
13 concerning:**
14 **(A) the use of money received under subsection (a); and**
15 **(B) the balances in any accounts or funds established by
16 the subsidiary corporation; and**
17 **(3) may deposit money received under subsection (a) in an**

- 2 **(A) administered by the subsidiary corporation; and**

- 4 **(c) A subsidiary corporation established under this section is**

- 7 **6 of this chapter; and**
- 8 **(2) any other directors that the members of the commission**
