

# COMMITTEE REPORT

---

## MADAM PRESIDENT:

The Senate Committee on Local Government, to which was referred Senate Bill No. 107, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1           Page 1, between the enacting clause and line 1, begin a new  
2 paragraph and insert:  
3           "SECTION 1. IC 36-3-6-10 IS ADDED TO THE INDIANA CODE  
4 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
5 1, 2012]: **Sec. 10. (a) As used in this section, "compensation" means**  
6 **the total of all money paid to a member of the city fiscal body for**  
7 **performing duties as a member of the city fiscal body, regardless**  
8 **of the source of funds from which the money is paid. The term**  
9 **includes all employee benefits paid to a member, including life**  
10 **insurance, health insurance, disability insurance, retirement**  
11 **benefits, and pension benefits.**  
12           **(b) A member of the city fiscal body may waive the officer's**  
13 **compensation for any year by filing a notice that satisfies the**  
14 **following:**  
15           **(1) The notice is in writing.**  
16           **(2) The notice states in substance all of the following:**  
17           **(A) That the individual is a member of the city fiscal body.**  
18           **(B) The calendar year covered by the notice.**  
19           **(C) That the member waives compensation under this**  
20 **section.**  
21           **(D) That the member understands that the notice is**

- 1           **irrevocable beginning January 1 of the year covered by the**  
 2           **notice.**
- 3           **(3) The notice is signed by the member of the city fiscal body**  
 4           **who wants to waive compensation.**
- 5           **(c) A member of the city fiscal body who wants to waive**  
 6           **compensation under this section must file the notice with the city**  
 7           **fiscal officer before January 1 of the year covered by the notice.**
- 8           **(d) A notice filed under this section is irrevocable beginning**  
 9           **January 1 of the year covered by the notice.**
- 10          **(e) A member of the city fiscal body who files a notice under this**  
 11          **section:**
- 12           **(1) is not entitled to compensation for duties performed in the**  
 13           **year covered by the notice; and**
- 14           **(2) may not be paid compensation for duties performed in the**  
 15           **year covered by the notice."**
- 16          Page 1, between lines 15 and 16, begin a new paragraph and insert:  
 17          "SECTION 3. IC 36-4-7-12 IS ADDED TO THE INDIANA CODE  
 18          AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
 19          1, 2012]: **Sec. 12. (a) As used in this section, "compensation" means**  
 20          **the total of all money paid to a member of the city fiscal body for**  
 21          **performing duties as a member of the city fiscal body, regardless**  
 22          **of the source of funds from which the money is paid. The term**  
 23          **includes all employee benefits paid to a member, including life**  
 24          **insurance, health insurance, disability insurance, retirement**  
 25          **benefits, and pension benefits.**
- 26          **(b) A member of the city fiscal body may waive the officer's**  
 27          **compensation for any year by filing a notice that satisfies the**  
 28          **following:**
- 29           **(1) The notice is in writing.**
- 30           **(2) The notice states in substance all of the following:**
- 31            **(A) That the individual is a member of the city fiscal body.**  
 32            **(B) The calendar year covered by the notice.**  
 33            **(C) That the member waives compensation under this**  
 34            **section.**
- 35            **(D) That the member understands that the notice is**  
 36            **irrevocable beginning January 1 of the year covered by the**  
 37            **notice.**
- 38           **(3) The notice is signed by the member of the city fiscal body**  
 39           **who wants to waive compensation.**
- 40          **(c) A member of the city fiscal body who wants to waive**  
 41          **compensation under this section must file the notice with the city**  
 42          **fiscal officer before January 1 of the year covered by the notice.**

1           **(d) A notice filed under this section is irrevocable beginning**  
2           **January 1 of the year covered by the notice.**

3           **(e) A member of the city fiscal body who files a notice under this**  
4           **section:**

5                 **(1) is not entitled to compensation for duties performed in the**  
6                 **year covered by the notice; and**

7                 **(2) may not be paid compensation for duties performed in the**  
8                 **year covered by the notice."**

9           Renumber all SECTIONS consecutively.  
              (Reference is to SB 107 as introduced.)

**and when so amended that said bill do pass .**
