## MADAM PRESIDENT:

The Senate Committee on Education and Career Development, to which was referred Senate Bill No. 182, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 1, line 4, delete "shall:" and insert "**shall**".
- 2 Page 1, line 5, delete "(1)".
- 3 Page 1, run in lines 4 through 5.
- 4 Page 1, line 7, delete "for:" and insert "**for**".
- 5 Page 1, line 8, delete "(A)".
- 6 Page 1, run in lines 7 through 8.
- 7 Page 1, line 9, delete "IC 21-42-1-3); and" and insert "**IC**
- 8 **21-42-1-3). The commission shall create a state course numbering**
- 9 **system into which each state educational institution shall map the**
- 10 **state educational institution's unique course numbers."**
- 11 Page 1, delete lines 10 through 15.
- 12 Page 2, line 2, delete "institution shall" and insert "**institution, in**
- 13 **collaboration with the commission for higher education, shall:"**.
