

COMMITTEE REPORT

MADAM PRESIDENT:

The Senate Committee on Appropriations, to which was referred House Bill No. 1367, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

1 Page 1, line 4, after "budget" insert "**, in consultation with the**
2 **Indiana School for the Deaf, the department of education, the state**
3 **department of health, and the office of the secretary of family and**
4 **social services,**".

5 Page 1, line 4, delete "determine" and insert "**recommend to the**
6 **general assembly through the budget process**".

7 Page 1, line 6, after "IC 20-35-11." insert "**Until the center for deaf**
8 **and hard of hearing education is established and operating, the**
9 **Indiana School for the Deaf shall continue to provide those services**
10 **that will be transferred from the Indiana School for the Deaf to the**
11 **center for deaf and hard of hearing education or local education**
12 **agencies at the time the center is established and operating.**".

13 Page 7, between lines 20 and 21, begin a new paragraph and insert:
14 "SECTION 7. IC 8-1-2.8-14 IS AMENDED TO READ AS
15 FOLLOWS [EFFECTIVE JULY 1, 2012]: Sec. 14. A surcharge shall
16 be collected on the regular monthly bill that a LEC sends to each of its
17 customers. The surcharge may be separately identified on customers'
18 bills as a special surcharge for the provision of services, including
19 telecommunications devices as provided in section 10(4) of this
20 chapter, to **deaf, hard of hearing, ~~impaired~~** and speech impaired
21 persons."

- 14 **(2) Until the center for deaf and hard of hearing education is**
- 15 **established and operating,** outreach services.
- 16 **(3) Until the center for deaf and hard of hearing education is**
- 17 **established and operating,** consultative services to local
- 18 educational agencies to assist the agencies in meeting the needs
- 19 of locally enrolled students with hearing disabilities.
- 20 **(b) The state board of finance and the budget agency may not**
- 21 **transfer for use by or for the center for deaf and hard of hearing**
- 22 **education any appropriation made to the Indiana School for the**
- 23 **Deaf by P.L.229-2011."**

- 31 **spoken language (oral), or any combination of these skills)."**

- 40 Page 15, between lines 7 and 8, begin a new paragraph and insert:
- 41 "SECTION 18. [EFFECTIVE UPON PASSAGE] **(a) The state**
- 42 **board of education shall, before October 1, 2012, make**

1 **recommendations to the legislative council (in an electronic format**
2 **under IC 5-14-6) and to the budget committee concerning the**
3 **unique and appropriate methods of evaluation and accountability**
4 **that should be applied to the Indiana School for the Blind and**
5 **Visually Impaired and the Indiana School for the Deaf. The state**
6 **board of education shall include in its recommendation any**
7 **proposed statutory changes or rule changes that the state board**
8 **believes to be appropriate.**
9 **(b) This SECTION expires July 1, 2013."**
10 Renumber all SECTIONS consecutively.
