DIGEST OF SB 403 (Updated March 20, 2013 12:01 pm - DI 96)

**Citations Affected:** IC 9-18.

**Synopsis:** Disabled Hoosier veteran license plate. Provides for the issuance of a disabled Hoosier veteran license plate to a person who: (1) has been rated by the United States Department of Veterans Affairs (department) as being at least 50% disabled with at least a 30% mobility disability rating; and (2) receives service connected compensation from the department. (Current law provides that the person must be rated 100% disabled.)

**Effective:** July 1, 2013.

## ENGROSSED SENATE BILL No. 403

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 9-18-18-1, AS AMENDED BY P.L.87-2010,  
2 SECTION 12, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2013]: Sec. 1. (a) A person may apply for, receive, and display  
4 a disabled Hoosier veteran license plate on the person's vehicle for  
5 private and personal use if the person, as the result of having served in  
6 the armed forces of the United States, has:  
7 (1) lost sight in both eyes or suffered permanent impairment of  
8 vision in both eyes to the extent of being eligible for  
9 service-connected compensation for the loss;  
10 (2) suffered the loss of one (1) or both feet or the permanent loss  
11 of use of one (1) or both feet;  
12 (3) suffered the loss of one (1) or both hands or the permanent  
13 loss of use of one (1) or both hands;  
14 (4) a United States Department of Veterans Affairs disability  
15 rating for a physical condition that precludes the person from  
16 walking without pain or difficulty; or  
17 (5) been rated by the United States Department of Veterans
