I move that Engrossed Senate Bill 1 be amended to read as follows:

- 1 Page 5, delete lines 7 through 9, begin a new line block indented  
2 and insert:  
3 **"(1) who is employed by a public school or who contracts with**  
4 **public school;"**.  
5 Page 5, delete lines 14 through 15, begin a new paragraph and  
6 insert:  
7 **"Sec. 2. As used in this chapter, "public school" refers to the**  
8 **following:**  
9 **(1) A school corporation (as defined in IC 20-18-2-16(a)).**  
10 **(2) A charter school (as defined in IC 20-18-2-2.5). "**  
11 Page 5, delete lines 24 through 32, begin a new paragraph and  
12 insert:  
13 **"Sec. 5. A public school may designate an individual to serve as**  
14 **a designated school protection officer. A public school that desires**  
15 **to have one (1) or more designated school protection officers shall**  
16 **provide the notice prescribed by the public school safety board**  
17 **under IC 10-21-1-9 to the school safety board."**  
18 Page 5, line 33, delete "(3) Each school", begin a new paragraph and  
19 insert:  
20 **"Sec. 6. Each public school"**.  
21 Page 5, line 36, delete "6." and insert "7".  
22 Page 5, line 39, delete "7." and insert "8".  
23 Page 5, line 40, delete "of the school" and insert **"or contractor of**  
24 **the public school"**.

- 1 Page 6, delete lines 1 through 7.
- 2 Page 9, line 32, after "IC 10-19-12;" and insert "**and**".
- 3 Page 9, line 35, delete "risk;" and insert "**risk.**".
- 4 Page 9, delete lines 36 through 40.
- 5 Page 10, line 7, delete "approve an application submitted by the"
- 6 and insert "**receive notices under IC 10-19-12-5 in the form and with**
- 7 **the information prescribed by the board.**".
- 8 Page 10, delete lines 8 through 12.
- 9 Page 13, delete lines 40 through 42, begin a new line block indented
- 10 and insert:
- 11 **(1) a school corporation (as defined in IC 20-18-2-16(a)); or**
- 12 **(2) a charter school (as defined in IC 20-18-2-2.5)."**
- 13 Page 14, delete lines 1 through 2.
