- 9 Page 10, delete lines 1 through 2.
- 10 Page 10, line 3, delete "8." and insert "7."
- 11 Page 10, delete lines 7 through 12.
- 12 Page 10, between lines 12 and 13, begin a new paragraph and insert:
- 13 "SECTION 6. IC 20-26-5-36.5 IS ADDED TO THE INDIANA

- 15 [EFFECTIVE JULY 1, 2013]: **Sec. 36.5. (a) A school corporation,**
- 16 **including a charter school, may not prohibit a school employee**
- 17 **from possessing a firearm on school property if the school**
- 18 **employee meets the requirements established by a school**
- 19 **corporation or charter school in a policy established in subsection**
- 20 **(b).**
- 21 **(b) The governing body of a school corporation or charter**
- 22 **school shall adopt a policy establishing guidelines or standards for**
- 23 **allowing a school employee to possess a firearm on school property**
- 24 **under subsection (a). The guidelines must meet the minimum**

- 1 **standards or guidelines established by the secured school safety**
- 2 **board under IC 10-21-1-3(a)(4)."**
