I move that Engrossed Senate Bill 519 be amended to read as follows:

- 1 Page 31, between lines 5 and 6, begin a new paragraph and insert:
- 2 "SECTION 83. IC 3-11-8-6.3, AS ADDED BY SEA 518-2013,
- 3 SECTION 56, IS REPEALED [EFFECTIVE JULY 1, 2013]. ~~Sec. 6.3:~~
- 4 ~~The polls may not be located in a structure on or in which is located~~
- 5 ~~any display visible to a voter of political preference or party allegiance,~~
- 6 ~~including any pictures, photographs, or other likenesses of any~~
- 7 ~~currently elected federal, state, county, or local official."~~
- 8 Page 53, between lines 3 and 4, begin a new paragraph and insert:
- 9 "SECTION 109. IC 3-14-3-16, AS AMENDED BY SEA 518-2013,
- 10 SECTION 98, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 11 JULY 1, 2013]: Sec. 16. (a) As used in this section, "electioneering"
- 12 includes expressing support or opposition to any candidate or political
- 13 party or expressing approval or disapproval of any public question in
- 14 any manner that could reasonably be expected to convey that support
- 15 or opposition to another individual. ~~The term includes wearing or~~
- 16 ~~displaying an article of clothing, sign, button, or placard that states the~~
- 17 ~~name of any political party or includes the name, picture, photograph,~~
- 18 ~~or other likeness of any currently elected federal, state, county, or local~~
- 19 ~~official.~~ The term does not include expressing support or opposition to
- 20 a candidate or a political party or expressing approval or disapproval
- 21 of a public question in:
- 22 (1) material mailed to a voter; or
- 23 (2) a telephone or an electronic communication with a voter.
- 24 (b) A person who knowingly does any electioneering:

- 1 (1) on election day within:
 - 2 (A) the polls; or
 - 3 (B) the chute;
 - 4 (2) within an area in the office of the circuit court clerk or a
 - 5 satellite office of the circuit court clerk established under
 - 6 IC 3-11-10-26.3 used by an absentee voter board to permit an
 - 7 individual to cast an absentee ballot; or
 - 8 (3) except for a voter who is:
 - 9 (A) the person's spouse;
 - 10 (B) an incapacitated person (as defined in IC 29-3-1-7.5) for
 - 11 whom the person has been appointed the guardian (as defined
 - 12 in IC 29-3-1-6); or
 - 13 (C) a member of the person's household;
 - 14 in the presence of a voter whom the person knows possesses an
 - 15 absentee ballot provided to the voter in accordance with Indiana
 - 16 law;
 - 17 commits a Class A misdemeanor."
 - 18 Renumber all SECTIONS consecutively.
