MR. SPEAKER:

I move that House Bill 1041 be amended to read as follows:

- 1 Page 1, line 3, delete "A person who files a petition to establish or"
- 2 and insert "**If a person files a petition to establish or modify**
- 3 **guardianship of an individual who is less than eighteen (18) years**
- 4 **of age, any person who:**
- 5 **(1) is a party to the guardianship proceeding; and**
- 6 **(2) has knowledge that:**
- 7 **(A) the person filing the petition has been determined to be**
- 8 **a perpetrator of a substantiated assessment of child abuse**
- 9 **or neglect;**
- 10 **(B) the child named in the petition has been a victim of a**
- 11 **substantiated assessment of child abuse or neglect;**
- 12 **(C) the child named in the petition has been determined to**
- 13 **be a child in need of services under IC 31-34; or**
- 14 **(D) the child named in the petition has been involved in an**
- 15 **informal adjustment under IC 31-34-8;**
- 16 **shall inform the court in writing that the petitioner is a person**
- 17 **described in subdivision (2)(A) or the child named in the petition**
- 18 **is a child described in subdivision (2)(B), (2)(C), or (2)(D)."**

- 20 Page 2, delete lines 1 through 9.
- 21 Page 2, line 10, delete "(d)" and insert "**(b)**".
- 22 Page 2, line 10, after "to" insert "**establish or**".
- 23 Page 2, line 18, delete "(a) A person who files a".

- 11 or".
- 12 Page 3, delete lines 40 through 42.
- 13 Page 4, delete lines 1 through 20.
- 14 Page 4, line 21, delete "(d) A court reviewing a petition to" and
- 15 insert "**A court reviewing a petition to establish or**".
- 16 Run in page 3, line 39 through page 4, line 21.
