MR. SPEAKER:

I move that Engrossed Senate Bill 207 be amended to read as follows:

- 1 Page 2, after line 41, begin a new paragraph and insert:
- 2 "SECTION 3. IC 21-14-12 IS ADDED TO THE INDIANA CODE
- 3 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 4 JULY 1, 2013]:
- 5 **Chapter 12. Resident Tuition for Veterans**
- 6 **Sec. 1. As used in this chapter, "qualified veteran" means an**
- 7 **individual who:**
- 8 **(1) served in the armed forces of the United States; and**
- 9 **(2) received an honorable discharge.**
- 10 **Sec. 2. A qualified veteran who enrolls in a state educational**
- 11 **institution not later than twelve (12) months after the date of the**
- 12 **qualified veteran's discharge from the armed forces of the United**
- 13 **States is eligible to pay the resident tuition rate determined by the**
- 14 **state educational institution for an undergraduate course taken by**
- 15 **the qualified veteran while attending the state educational**
- 16 **institution.**
- 17 **Sec. 3. (a) Subject to subsection (b), a qualified veteran is**
- 18 **eligible to pay a resident tuition rate for an undergraduate course:**
- 19 **(1) regardless of whether the qualified veteran has resided in**
- 20 **Indiana long enough after receiving a discharge from the**
- 21 **armed forces of the United States to establish Indiana**
- 22 **residency under the otherwise applicable policies of the state**
- 23 **educational institution; and**
- 24 **(2) regardless of whether the qualified veteran has returned**

1 to Indiana for the primary purpose of attending the state
2 educational institution.
3 **(b) A qualified veteran must provide to the state educational**
4 **institution, not later than twelve (12) months after the date the**
5 **qualified veteran enrolls in the state educational institution:**
6 **(1) proof that the qualified veteran has registered to vote in**
7 **Indiana;**
8 **(2) proof that the qualified veteran has:**
9 **(A) obtained an Indiana driver's license or a state**
10 **identification card under IC 9-24; or**
11 **(B) registered the qualified veteran's motor vehicle in**
12 **Indiana; or**
13 **(3) any other proof of residency as approved by the**
14 **commission.**
15 **If a qualified veteran fails to comply with this subsection, the**
16 **qualified veteran is subject to the tuition policies determined by the**
17 **state educational institution."**
18 Renumber all SECTIONS consecutively.
