I move that Engrossed Senate Bill 487 be amended to read as follows:

- 1 Page 2, line 16, delete "The" and insert "**Except for a person who**
- 2 **exports live cervidae or other species for which a game breeders**
- 3 **license is required under this chapter, the**".
- 4 Page 3, line 19, delete "one thousand dollars (\$1,000)." and insert
- 5 "**two thousand five hundred dollars (\$2,500)**".
- 6 Page 3, line 21, after "with" insert "**satisfactory**".
- 7 Page 3, line 26, delete "and".
- 8 Page 3, line 27, delete "(\$1,000)." and insert "**(\$1,000); and**".
- 9 Page 3, between lines 27 and 28, begin a new line block indented
- 10 and insert:
- 11 "**(3) has not committed a pattern of violations of this chapter**
- 12 **under the person's current license.**
- 13 **(d) The department shall use the fees collected in this section to**
- 14 **administer this chapter.**".
- 15 Page 3, line 29, after "(1)" insert "**legally**".
- 16 Page 4, line 28, delete "preserve;" and insert "**preserve, including**
- 17 **information concerning where the cervidae were acquired;**".
- 18 Page 4, line 34, delete "preserve;" and insert "**preserve, including**
- 19 **information concerning where the cervidae were exported;**".
- 20 Page 4, between lines 41 and 42, begin a new paragraph and insert:
- 21 "**(c) The licensed owner shall annually submit copies of the**
- 22 **records required under this section to the department.**".
- 23 Page 5, line 10, after "weapon" insert "**that is allowed to be used**
- 24 **to hunt deer, under rules adopted by the department.**".

- 1 Page 5, line 19, delete "The" and insert "**Except as provided in**
 2 **subsection (c), the**".
- 3 Page 5, between lines 21 and 22, begin a new paragraph and insert:
 4 "**(c) A licensed owner who knowingly or intentionally commits**
 5 **a flagrant violation of this chapter is not eligible for reinstatement**
 6 **under subsection (b).**".
- 7 Page 5, line 23, delete "tuberculosis and".
- 8 Page 5, line 25, delete "tuberculosis,".
- 9 Page 5, line 26, delete "disease," and insert "**disease**".
- 10 Page 5, delete lines 28 through 31.
- 11 Page 5, line 32, delete "15. (a) Subject to" and insert "**14. (a) Except**
 12 **as provided in**".
- 13 Page 5, line 33, delete "do not" and insert "**may**".
- 14 Page 5, line 33, delete "any".
- 15 Page 5, line 35, after "indemnification" insert "**for chronic wasting**
 16 **disease**".
- 17 Page 5, line 36, after "IC 15-17-10-6" insert "**only**".
- 18 Page 5, line 41, delete "Indiana;" and insert "**an area within a one**
 19 **hundred (100) mile radius of the hunting preserve;**".
- 20 Page 6, line 4, delete "16." and insert "**15. (a) Nothing in this**
 21 **chapter limits the Indiana board of animal health's duties,**
 22 **responsibilities, or authority under IC 15-17.**
 23 **(b)**".
- 24 Page 6, line 8, delete "17." and insert "**16.**".
- 25 Page 6, between lines 9 and 10, begin a new paragraph and insert:
 26 "SECTION 10. IC 14-22-32-1 IS AMENDED TO READ AS
 27 FOLLOWS [EFFECTIVE JULY 1, 2013]: Sec. 1. This chapter does not
 28 apply to the following:
- 29 (1) Conservation officers or other law enforcement officers.
- 30 (2) Game birds or exotic mammals in shooting preserves licensed
 31 under IC 14-22-31.
- 32 (3) A person who takes a feral exotic mammal when the feral
 33 exotic mammal is causing damage to property that is owned or
 34 leased by the person.

1 (4) A person who is authorized by the department under
2 extraordinary circumstances to take an exotic mammal.

3 **(5) Cervidae in a hunting preserve licensed under**
4 **IC 14-22-31.3."**

5 Renumber all SECTIONS consecutively.
