HOUSE BILL No. 1341

DIGEST OF HB 1341 (Updated January 29, 2013 12:07 pm - DI 116)

Citations Affected: IC 21-18.

Synopsis: Standard transcripts and college applications. Establishes the Indiana e-transcript program (program). Provides that the commission for higher education shall administer the program. Provides that, beginning July 1, 2015, the program will allow all students at all accredited high schools to request that their transcripts be transmitted electronically to state educational institutions, participating Indiana not-for-profit or privately endowed institutions, and participating Indiana institutions authorized by the board for proprietary education. Provides that a governing body of an accredited nonpublic secondary school may elect to use the common electronic transcript. Requires the department of education, in collaboration with state educational institutions and the commission for higher education, to develop a common electronic transcript.

Effective: July 1, 2013.

HOUSE BILL No. 1341

A BILL FOR AN ACT to amend the Indiana Code concerning higher education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 21-18-12 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2013]:

4 **Chapter 12. Indiana E-Transcript Program**

5 **Sec. 1. (a) The Indiana e-transcript program is created to allow**
6 **students at all accredited high schools located in Indiana to request**
7 **that the student's school transcripts be transmitted electronically**
8 **to state educational institutions, participating Indiana**
9 **not-for-profit or privately endowed institutions, and participating**
10 **Indiana institutions authorized by the board for proprietary**
11 **education established by IC 21-18.5-5-1.**

12 **(b) The commission shall administer the program.**

13 **(c) Beginning July 1, 2013, the department of education**
14 **established by IC 20-19-3-1, in collaboration with the state**
15 **educational institutions and the commission, shall develop a**
16 **common electronic transcript, using common data fields and**
17 **formats that are required by state educational institutions.**

1 **(d) Not later than July 1, 2015, all public secondary schools shall**
2 **use the common electronic transcript developed by the department**
3 **of education.**

4 **(e) The governing body of an accredited nonpublic secondary**
5 **school may elect to use the common electronic transcript developed**
6 **by the department of education.**

7 **Sec. 2. The commission, in consultation with the department of**
8 **education established by IC 20-19-3-1, may adopt rules under**
9 **IC 4-22-2 to implement this chapter.**
