DIGEST OF HB 1450 (Updated February 13, 2013 2:23 pm - DI 96)

Citations Affected: Noncode.

Synopsis: Commuter transportation districts. Requires the joint study committee on transportation and infrastructure assessment solutions to study during the 2013 legislative interim: (1) the composition of the board of trustees of the commuter transportation district; (2) all funding for the board of trustees; (3) use of public mass transit funds (PMTF); (4) ridership numbers; and (5) possible expansion of rail lines used by the Chicago, South Shore, and South Bend Railroad.

Effective: July 1, 2013.

Be it enacted by the General Assembly of the State of Indiana:

Delete the title and insert the following:

A BILL FOR AN ACT concerning the commuter transportation joint study committee.

Page 1, delete lines 1 through 17.

Delete pages 2 through 3.

Page 4, delete lines 1 through 8.

Page 4, line 9, delete "2." and insert "1."

Page 4, line 11, delete "IC 8-5-15-3, as amended" and insert "**IC 8-5-15-3.**

(b) As used in this SECTION, "committee" refers to the joint study committee on transportation and infrastructure assessment solutions.

(c) During the 2013 legislative interim, the committee shall:

(1) study the:

(A) composition of the board;

(B) all funding sources and expenditures concerning the board including capital expenditures for the Chicago, South Shore, and South Bend Railroad;

(C) use of public mass transit funds (PMTF);

(D) ridership numbers for the Chicago, South Shore, and South Bend Railroad;

(E) expansion of the rail lines used by the Chicago, South Shore, and South Bend Railroad; and

(2) make recommendations to the legislative council before November 1, 2013.

(d) This SECTION expires December 1, 2013."

Page 4, delete lines 12 through 29.

Re-number all SECTIONS consecutively.
