*Your Committee on Public Health, to which was referred House Bill 1182, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 5, line 42, after "person" begin a new line double block
- 2 indented and insert:
- 3 **"(A) is less than eighteen (18) years of age and is not**
- 4 **authorized to consent under IC 16-36-1-3(a)(2); or".**
- 5 Page 6, line 1, before "has" begin a new line double block indented
- 6 and insert:
- 7 **"(B)".**
- 8 Page 6, delete lines 5 through 8, begin a new line triple block
- 9 indented and insert:
- 10 **"(i) appointed by the individual under IC 16-36-1-7 to**
- 11 **serve as the individual's health care representative;**
- 12 **(ii) authorized to act under IC 30-5-5-16 and**
- 13 **IC 30-5-5-17 as the individual's attorney in fact with**
- 14 **authority to consent to or refuse health care for the**

- 2 **(iii) appointed by a court as the individual's guardian**
- 3 **under IC 16-36-1-8."**

- 7 Page 7, run in lines 37 through 39.
- 8 Page 7, delete lines 40 through 41.
- 9 Page 8, line 13, delete "entry into" and insert "**existence in**".
- 10 Page 8, line 13, delete "record that can" and insert "**record.**".
- 11 Page 8, delete line 14.
- 12 Page 10, line 39, delete "for any reason".
- 13 Page 11, line 17, delete "any of the following individuals who are"
- 14 and insert "**the following individuals:**
- 15 **(1) The treating physician shall consult with any**
- 16 **representative who is available, willing, and competent to act.**
- 17 **(2) If the declarant does not have a representative or if a**
- 18 **representative is not available, willing, and competent to act,**
- 19 **the treating physician shall consult with any of the following**
- 20 **individuals who are available, willing, and competent to act:**
- 21 **(A) The declarant's spouse.**
- 22 **(B) An adult child of the declarant, or, if the declarant has**
- 23 **more than one (1) adult child, a majority of the children**
- 24 **who are reasonably available for consultation.**
- 25 **(C) A parent of the declarant.**
- 26 **(D) An adult sibling of the declarant, or, if the declarant**
- 27 **has more than one (1) adult sibling, a majority of the**
- 28 **siblings who are reasonably available for consultation.**

1 **(E) An individual with firsthand knowledge of the**
2 **declarant's intentions."**
