MR. SPEAKER:

*Your Committee on Ways and Means, to which was referred Senate Bill 585, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Replace the effective date in SECTION 2 with "[EFFECTIVE JULY
- 2 1, 2013]".
- 3 Page 1, delete lines 1 through 17, begin a new paragraph and insert:
- 4 "SECTION 1. IC 2-5-28.5-4.6 IS ADDED TO THE INDIANA
- 5 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 6 [EFFECTIVE JULY 1, 2013]: **Sec. 4.6. (a) In calendar year 2013, the**
- 7 **committee shall study the feasibility and economic impact of**
- 8 **adding a second port to serve Lake Michigan, including channels**
- 9 **that are ordinarily navigable to Lake Michigan.**
- 10 **(b) The legislative services agency shall furnish the committee's**
- 11 **final report for calendar year 2013 to the budget committee in an**
- 12 **electronic format promptly after the final report becomes**
- 13 **available.**
- 14 **(c) This section expires June 30, 2014."**
- 15 Page 2, delete lines 1 through 17.
- 16 Page 2, line 27, delete "2012." and insert "2013."

2 Page 2, delete lines 41 through 42.

5 Page 40, line 38, delete "Aviation." and insert "**Aviation**
6 **management at an executive level.**".

7 Page 40, delete lines 41 through 42, begin a new paragraph and
8 insert:

9 "**(j) A person appointed by an appointing authority under**
10 **subsection (b) may not personally have, or be employed by or have**
11 **an ownership interest in an entity that has, a significant**
12 **contractual or business relationship with the airport authority.**

13 **(k) The board of an airport authority described in subsection (a)**
14 **shall contract with a certified public accountant for an annual**
15 **financial audit of the airport authority. The certified public**
16 **accountant may not be selected without review of the accountant's**
17 **proposal and approval of the accountant by the state board of**
18 **accounts. The certified public accountant may not have a**
19 **significant financial interest, as determined by the board of the**
20 **airport authority, in a project, facility, or service owned by, funded**
21 **by, or leased by or to the airport authority. The certified public**
22 **accountant shall present the annual financial audit not later than**
23 **four (4) months after the end of the airport authority's fiscal year.**
24 **The certified public accountant shall also perform a study and**
25 **evaluation of the airport authority's internal accounting controls**
26 **and shall express an opinion on the controls that were in effect**
27 **during the audit period. The board of the airport authority shall**
28 **pay the cost of the annual financial audit. In addition, the state**
29 **board of accounts may at any time conduct an audit of any phase**
30 **of the operations of the airport authority. The airport authority**
31 **shall pay the cost of any audit by the state board of accounts."**

7 **northwestern Indiana and, if so, what the appropriate levels**
8 **of the trauma centers should be to care for those injuries, in**
9 **terms of the trauma center rating system of the American**
10 **College of Surgeons.**
11 **(2) The options for offering a medical school program for**
12 **third and fourth year medical students in northwestern**
13 **Indiana.**
14 **(b) The development authority shall report its findings to the**
15 **budget committee not later than November 1, 2014.**
16 **(c) This section expires June 30, 2015.**
17 **SECTION 5. [EFFECTIVE JULY 1, 2013] (a) The general**
18 **assembly urges the legislative council to assign for interim study in**
19 **2013 the topic of the responsibility of local units for providing fire**
20 **protection, police protection, and other governmental services to**
21 **the Indiana ports.**
22 **(b) This SECTION expires January 1, 2014."**
