*Your Committee on Public Health, to which was referred House Bill 1272, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 13, delete lines 7 through 19.
- 2 Page 18, line 32, delete "The board may seek injunctive relief to
- 3 prohibit any person" and insert "**If:**
- 4 **(1) the board receives a complaint against a person who is not**
- 5 **licensed under this article; and**
- 6 **(2) after review of the complaint, the board believes that**
- 7 **further action may be necessary;**
- 8 **the board shall refer the matter to the office of the attorney general**
- 9 **for investigation and any necessary legal action."**
- 10 Page 18, delete lines 33 through 34.
- 11 Page 24, line 5, reset in roman "or".
- 12 Page 24, line 7, delete "; or" and insert ".".
- 13 Page 24, delete line 8.
- 14 Page 24, line 28, delete "general nonmedical".
- 15 Page 25, between lines 4 and 5, begin a new line block indented and

- 1 insert:
- 2 **"(8) A person who provides nutritional or dietetic information**
- 3 **based upon information that is available to the public,**
- 4 **including the following:**
- 5 **(A) Principles of good nutrition and food preparation.**
- 6 **(B) Food to be included in the normal daily diet.**
- 7 **(C) The essential nutrients needed by the body.**
- 8 **(D) Recommended amounts of the essential nutrients based**
- 9 **on published information, as long as the published**
- 10 **information and source are made available, upon request,**
- 11 **at the time of consultation.**
- 12 **(E) The actions of nutrients on the body.**
- 13 **(F) The effects of deficiencies or excesses of nutrients.**
- 14 **(G) Food and supplements that are good sources of**
- 15 **essential nutrients.**
- 16 **(9) A person who practices dietetics or nutrition care services**
- 17 **for a close relative (as defined by IC 2-7-1-1.7) or a person**
- 18 **living in the same household."**
- 19 Page 25, line 8, strike "(a)".
- 20 Page 25, line 12, delete "Only a person licensed or otherwise".
- 21 Page 25, delete lines 13 through 15.
- 22 Page 25, line 16, strike "(b)".
- 23 Page 25, line 18, after "(1)" insert "**publishing information or**".
- 24 Page 25, line 18, after "disseminating" insert "**published or**".
- 25 Renumber all SECTIONS consecutively.
