## COMMITTEE REPORT

### MR. SPEAKER:

*Your Committee on Local Government, to which was referred House Bill 1333, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 1, between lines 16 and 17, begin a new paragraph and insert:
- 2 "SECTION 2. IC 36-2-9-2.5, AS ADDED BY P.L.120-2012,
- 3 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 4 JULY 1, 2013]: Sec. 2.5. (a) As used in this section, "training courses"
- 5 refers to training courses related to the office of county auditor that are
- 6 developed by the Association of Indiana Counties and approved by the
- 7 state board of accounts.
- 8 (b) An individual elected to the office of county auditor **on or** after
- 9 November 6, 2012, shall complete at least:
- 10 (1) fifteen (15) hours of training courses within one (1) year; and
- 11 (2) forty (40) hours of training courses within three (3) years;
- 12 after ~~beginning the county auditor's term:~~ **the individual is elected to**
- 13 **the office of county auditor.**
- 14 (c) **A training course that an individual completes:**
- 15 (1) **after being elected to the office of county auditor; and**
- 16 (2) **before the individual begins serving in the office of county**

1           **auditor;**  
 2           **shall be counted toward the requirements under subsection (b).**  
 3           **(d) An individual shall fulfill the training requirements**  
 4           **established by subsection (b) for each term to which the individual**  
 5           **is elected as county auditor.**

6           **(e) This subsection applies only to an individual appointed to fill**  
 7           **a vacancy in the office of county auditor. An individual described**  
 8           **in this subsection may, but is not required to, take training courses**  
 9           **required by subsection (b). If an individual described in this**  
 10           **subsection takes a training course required by subsection (b) for an**  
 11           **elected county auditor, the county shall pay for the training course**  
 12           **as if the individual had been an elected county auditor."**

 26 Page 4, after line 15, begin a new paragraph and insert:  
 27 "**(f) This subsection applies only to an individual appointed to**  
 28 **fill a vacancy in the office of county surveyor. An individual**  
 29 **described in this subsection may, but is not required to, take any**  
 30 **training courses required by subsection (c). If an individual**  
 31 **described in this subsection takes a training course required by**  
 32 **subsection (c) for an elected county surveyor, the county shall pay**

1       **for the training course as if the individual had been an elected**  
2       **county surveyor."**

3       Renumber all SECTIONS consecutively.  
      (Reference is to HB 1333 as introduced.)
