*Your Committee on Ways and Means, to which was referred Senate Bill 537, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 4, delete lines 17 through 28, begin a new paragraph and
- 2 insert:
- 3 "SECTION 14. IC 9-13-2-44, AS AMENDED BY P.L.125-2012,
- 4 SECTION 10, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 5 JULY 1, 2013]: Sec. 44. (a) "Disposal facility" means a person, firm,
- 6 limited liability company, corporation, or other legal entity that, in the
- 7 course of business, engages in the acquisition and dismantling or
- 8 demolition of vehicles, motorcycles, semitrailers, or recreational
- 9 vehicles or their remains for the benefit of reusable components and
- 10 parts or recyclable materials.
- 11 (b) The term includes the following enterprises:
- 12 (1) An automotive salvage recycler.
- 13 (2) A hulk crusher.
- 14 (c) ~~The term does not include~~ (3) A scrap metal processor."

- 17 **85-2013, SECTION 37. The general assembly intends to repeal**
- 18 **IC 9-23-2-4.**
- 19 **(c) This SECTION expires December 31, 2013.**
