**MR. SPEAKER:**

*Your Committee on Public Health, to which was referred House Bill 1315, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1           Page 1, between the enacting clause and line 1, begin a new
- 2           paragraph and insert:
- 3           "SECTION 1. IC 16-18-2-288 IS AMENDED TO READ AS
- 4           FOLLOWS [EFFECTIVE JULY 1, 2013]: Sec. 288. (a) "Practitioner",
- 5           for purposes of IC 16-42-19, has the meaning set forth in
- 6           IC 16-42-19-5.
- 7           (b) "Practitioner", for purposes of IC 16-41-14, has the meaning set
- 8           forth in IC 16-41-14-4.
- 9           (c) "Practitioner", for purposes of IC 16-42-21, has the meaning set
- 10          forth in IC 16-42-21-3.
- 11          (d) "Practitioner", for purposes of IC 16-42-22 **and IC 16-42-25**,
- 12          has the meaning set forth in IC 16-42-22-4.5."
- 13          Page 2, line 11, delete "product for the specified indicated use." and

- 1 insert "**product.**".
- 2 Page 2, delete lines 12 through 13, begin a new line block indented  
3 and insert:
- 4 "**(2) The prescribing practitioner has:**
- 5 **(A) for a written prescription, signed on the line under**  
6 **which the words "May substitute" appear; or**
- 7 **(B) for an electronically transmitted prescription,**  
8 **electronically transmitted the instruction "May**  
9 **substitute".**
- 10 Page 2, line 14, delete "patient or the patient's authorized  
11 representative" and insert "**pharmacist has informed the customer of**  
12 **the substitution.**".
- 13 Page 2, delete line 15.
- 14 Page 2, line 16, delete "physician" and insert "**prescribing**  
15 **practitioner**".
- 16 Page 2, line 19, delete "physician" and insert "**practitioner**".
- 17 Page 2, line 20, before "biosimilar" insert "**interchangeable**".
- 18 Page 2, line 23, after "public" insert "**Internet**".
- 19 Page 2, delete lines 28 through 29, begin a new paragraph and  
20 insert:
- 21 "**Sec. 5. A written or electronic prescription for a biological**  
22 **product must comply with the requirements under IC 16-42-22-6.**"
- 23 Renumber all SECTIONS consecutively.  
(Reference is to HB 1315 as introduced.)
