*Your Committee on Employment, Labor and Pensions, to which was referred House Bill 1325, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 1, line 6, delete "member." and insert "**member to assist**
- 2 **another state under the Emergency Management Assistance**
- 3 **Compact.**
- 4 SECTION 2. IC 10-14-3-0.7 IS ADDED TO THE INDIANA CODE
- 5 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 6 1, 2013]: **Sec. 0.7. As used in this chapter, "Emergency**
- 7 **Management Assistance Compact" refers to IC 10-14-5.**
- 8 Page 4, line 25, after "deployed" delete "to" and insert "**on**".
- 9 Page 4, line 25, delete "unit," and insert "**unit to assist another**
- 10 **state under the Emergency Management Assistance Compact,**".
- 11 Page 5, between lines 26 and 27, begin a new paragraph and insert:
- 12 "SECTION 5. IC 10-14-4-0.3 IS ADDED TO THE INDIANA
- 13 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
- 14 [EFFECTIVE JULY 1, 2013]: **Sec. 0.3. As used in this chapter,**

- 1 **"backfill employee" has the meaning set forth in IC 10-14-3-0.5.**
 2 SECTION 6. IC 10-14-4-2, AS AMENDED BY P.L.107-2007,
 3 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 4 JULY 1, 2013]: Sec. 2. As used in this chapter, "eligible entity" means
 5 a county, a city, a town, a township, or an individual who has incurred
 6 loss **or cost** because of a disaster.
- 7 SECTION 7. IC 10-14-4-6, AS AMENDED BY P.L.110-2009,
 8 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 9 JULY 1, 2013]: Sec. 6. Subject to the restrictions under this chapter,
 10 the agency may use money in the fund to provide financial assistance
 11 as follows:
- 12 (1) To an eligible entity that:
- 13 (A) is not an individual;
- 14 (B) contains territory for which a disaster emergency has been
 15 declared by the governor;
- 16 (C) has suffered damage to the entity's public facilities because
 17 of the disaster for which the disaster emergency was declared;
- 18 (D) has applied to the department for financial assistance in
 19 the form of a grant; and
- 20 (E) complies with all other requirements established by the
 21 agency.
- 22 (2) To an eligible entity **that:**
- 23 **(A) is not an individual;**
- 24 **(B) contributes personnel to a mobile support unit**
 25 **deployed to assist another political subdivision in**
 26 **responding to a disaster emergency that has been declared**
 27 **by the governor;**
- 28 **(C) incurs the cost of one (1) or more backfill employees**
 29 **that are necessary to fill the position and perform the**
 30 **duties of an employee deployed on a mobile support unit;**
- 31 **(D) has applied to the department for financial assistance**
 32 **in the form of a grant; and**
- 33 **(E) complies with all other requirements established by the**
 34 **agency.**
- 35 **(3) To an eligible entity:**
- 36 (A) who is an individual;
- 37 (B) whose primary residence is located in territory for which:
- 38 (i) the United States Small Business Administration declares

- 1 a disaster; and
- 2 (ii) there has been no disaster declaration issued by the
- 3 President of the United States;
- 4 (C) who has suffered damage to the entity's primary residence
- 5 or individual property because of a disaster described in clause
- 6 (B); and
- 7 (D) who complies with all other requirements established by
- 8 the agency.

9 SECTION 8. IC 10-14-4-8.5 IS ADDED TO THE INDIANA CODE
 10 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
 11 1, 2013]: **Sec. 8.5. The agency may make a grant to an eligible
 12 entity under section 6(2) of this chapter for the cost of a backfill
 13 employee, but only if and to the extent the cost of the backfill
 14 employee represents extra cost to the political subdivision.**

15 SECTION 9. IC 10-14-4-11, AS AMENDED BY P.L.22-2005,
 16 SECTION 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 17 JULY 1, 2013]: Sec. 11. (a) The director shall adopt rules under
 18 IC 4-22-2 to carry out this chapter.

19 (b) **The director may adopt emergency rules in the manner
 20 provided under IC 4-22-2-37.1 to carry out the provisions of this
 21 chapter."**
