## MR. SPEAKER:

*Your Committee on Ways and Means, to which was referred House Bill 1465, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 2, line 2, after "III" delete ",".
- 2 Page 2, line 2, before "IV," reset in roman "or".
- 3 Page 2, line 2, after "IV" delete ",".
- 4 Page 2, line 2, delete "or V".
- 5 Page 2, between lines 12 and 13, begin a new paragraph and insert:
- 6 **"(e) Prescriptions for schedule V controlled substances may be**
- 7 **transmitted by an electronic prescription from the practitioner or**
- 8 **the agent of the practitioner to a pharmacy."**
- 9 Page 2, line 32, after "recommendations" insert **"to the general**
- 10 **assembly and the professional licensing agency"**.
- 11 Page 2, line 38, after "system," insert **"adding legend drugs to the**
- 12 **program,"**.
- 13 Page 3, line 16, delete "room".

- 1 Page 3, between lines 19 and 20, begin a new line block indented
- 2 and insert:
- 3 **"(5) One (1) practicing pharmacist appointed by the governor.**
- 4 **(6) The attorney general or the attorney general's designee."**
- 5 Page 3, line 20, delete "(5)" and insert "(7)".
- 6 Page 3, delete lines 21 through 22.
- 7 Page 3, between lines 25 and 26, begin a new paragraph and insert:
- 8 **"(f) Each member of the committee who is not a member of the**
- 9 **general assembly or a state employee is not entitled to per diem or**
- 10 **travel expenses.**
- 11 **(g) Each member of the committee who is a state employee but**
- 12 **not a member of the general assembly is entitled to the following:**
- 13 **(1) Reimbursement for traveling expenses as provided under**
- 14 **IC 4-13-1-4.**
- 15 **(2) Other expenses actually incurred in connection with the**
- 16 **member's duties as provided in the state policies and**
- 17 **procedures established by the Indiana department of**
- 18 **administration and approved by the budget agency.**
- 19 **(h) Each member of the committee who is a member of the**
- 20 **general assembly is entitled to the per diem, mileage, and travel**
- 21 **allowances paid to legislative members of interim study committees**
- 22 **established by the legislative council."**
- 23 Page 3, line 26, delete "(f)" and insert "(i)".
