DIGEST OF INTRODUCED BILL

Citations Affected: IC 9-13-2-109.3; IC 9-20-9-1.

Synopsis: Motorsports trailers. Defines "motorsports". Provides that a tractor-trailer combination used exclusively in connection with motorsports may exceed a total length of 60 feet.

Effective: July 1, 2013.

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 9-13-2-109.3 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2013]: **Sec. 109.3. "Motorsports", for**
4 **purposes of IC 9-20-9-1, has the meaning set forth in**
5 **IC 9-20-9-1(b).**

6 SECTION 2. IC 9-20-9-1 IS AMENDED TO READ AS FOLLOWS
7 [EFFECTIVE JULY 1, 2013]: Sec. 1. (a) As used in this section, "drive
8 away or tow away" means the delivery service performed by a transport
9 operator by which motor vehicles in transit are delivered by driving
10 singly or in combination by the towbar, saddlemount, or fullmount
11 methods or any lawful combination of those methods, including
12 coupling equipment or where a truck or tractor draws or tows a
13 semitrailer or trailer in transit.

14 **(b) As used in this section, "motorsports" means the group of**
15 **sports that are sanctioned by one (1) or more member clubs of the**
16 **Automobile Competition Committee for the United States.**

17 ~~(b)~~ (c) A combination of two (2) vehicles coupled together,



- 1 including load, may not exceed a total length of sixty (60) feet, except
- 2 for the following:
- 3 (1) A combination of two (2) vehicles coupled together that are
- 4 especially constructed to transport other vehicles or boats. **This**
- 5 **combination includes a tractor-trailer combination used**
- 6 **exclusively in connection with motorsports.**
- 7 (2) A combination of two (2) vehicles coupled together being
- 8 transported in a drive away or tow away service.
- 9 (3) A pole trailer owned by or operated for a public utility (as
- 10 defined in IC 8-1-2-1), while the pole trailer is being used in
- 11 connection with the utility services of the public utility.
- 12 (4) Trailers used in transporting oil field equipment or pipe for the
- 13 transmission of oil or gas.
