DIGEST OF INTRODUCED BILL

Citations Affected: IC 4-5-1-11.

Synopsis: Motor vehicle wholesalers. Provides that the secretary of state may not require by rule a wholesale dealer to sell a minimum number of vehicles per year. Voids existing rules.

Effective: July 1, 2013.

SENATE BILL No. 27



A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 4-5-1-11, AS AMENDED BY P.L.197-2011,
 2 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 3 JULY 1, 2013]: Sec. 11. **(a)** The secretary of state may adopt and
 4 enforce rules under IC 4-22-2 that are necessary to carry out:
 5 (1) IC 9-18-26;
 6 (2) IC 9-22-4;
 7 (3) IC 9-23-2;
 8 (4) IC 9-23-3; and
 9 (5) IC 9-23-6.

10 **(b)** A rule adopted by the secretary of state under subsection (a)
 11 that is necessary to carry out and enforce IC 9-23-2 may not
 12 require a wholesale dealer to sell a minimum number of vehicles
 13 per year. A rule that violates this subsection is void.

14 **(c)** 75 IAC 2-2-10(d)(6) and 75 IAC 2-2-11 are void. The
 15 publisher of the Indiana Administrative Code and Indiana Register
 16 shall remove 75 IAC 2-2-10(d)(6) and 75 IAC 2-2-11 from the

2 **31, 2013.**
